A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING THE ISSUANCE OF PURCHASE ORDERS TO INNOVATIVE EQUIPMENT SERVICES 2. LLC DBA CASE POWER & EQUIPMENT OF FLORIDA; BACHRODT FT, LLC DBA PALMETTO FORD OF MIAMI; BOZARD FORD CO.; AMERI-RECREATIONAL SPORTS, LLC.; KELLY COMPANY, GLADE & GROVE SUPPLY CO INC.; TAMPA CRANE & BODY ACQUISITION LLC DBA TAMPA CRANE; ALAN JAY CHEVROLET CADILLAC; ALAN JAY FORD LINCOLN MERCURY INC., GARBER CHEVROLET BUICK PONTIAC GMC; AND RIGHT TRAILERS, INC.; UTILIZING FLORIDA SHERIFF'S ASSOCIATION CONTRACT NO. FSA23-EQU21.0, FSA23-VEH21.1, AND FSA24-VEH32.0, AND SOURCEWELL CONTRACT NO. 0832923-AGCO, 093021-SWZ, AND 091521-NAF FOR THE PURCHASE OF NEW VEHICLES; AUTHORIZING THE CITY MANAGER TO ISSUE THE PURCHASE ORDERS AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (City) is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the Florida Sheriff's Association (FSA) and Sourcewell administer cooperative purchasing programs wherein solicitations are issued for a multitude of products and the resulting contracts are managed by FSA and Sourcewell; and

WHEREAS, the terms and conditions of the contracts awarded by FSA are extended and guaranteed to FSA members along with any unit of local government, political subdivision, or agency of the State of Florida; and

WHEREAS, contracts solicited by Sourcewell are accessible to federal, state, and municipal government entities along with other non-profit and educational entities; and

WHEREAS, the FSA issued Solicitation FSA23-EQU21.0 to obtain vendors for Equipment, FSA 23-VEH21.1 for Heavy Trucks and Buses, and FSA24-VEL32.0 for Pursuit, Administrative, & other Vehicles; and

WHEREAS, Innovative Equipment Services 2, LLC dba Case Power & Equipment of Florida (Case Power & Equipment), Kelly Tractor Company (Kelly Tractor), Ameri-Recreational Sports, LLC, and Right Trailers Inc. are four of the vendors awarded contracts under FSA23-EQU21.0; and

WHEREAS, Bachrodt FT, LLC dba Palmetto Ford of Miami (Palmetto Ford of Miami) is one of the

vendors awarded the contract under FSA23-VEL21.1; and

WHEREAS, Bozard Ford Co. and Garber Chevrolet Buick GMC, Inc. are two of the vendors awarded contracts under FSA24-VEL32.0; and

WHEREAS, Sourcewell issued RFP No. 0832923-AGCO to obtain vendors for AG Tractors, RFP No. 093021-SWZ for Street Sweepers and Specialty Sweepers, and RFP No. 019521-NAF for Automobiles, SUVs, Vans, and Light Trucks; and

WHEREAS, Glade & Grove Supply Co Inc. is one of the vendors that was awarded a contract under Sourcewell RFP No. 0832923-AGCO; and

WHEREAS, Tampa Crane & Body Acquisition LLC dba Tampa Crane (Tampa Crane) is one of the vendors that was awarded a contract under Sourcewell RFP No. 093021-SWZ; and

WHEREAS, Alan Jay Chevrolet Cadillac and Alan Jay Ford Lincoln Mercury are two of the vendors that were awarded a contract under Sourcewell RFP No. 091521-NAF; and

WHEREAS, utilizing FSA-23 EQU21.0, the City desires to issues purchase orders to Case Power & Equipment for one 2025 Case CX260 Excavator,

WHEREAS, utilizing FSA-23 EQU21.0, the City desires to purchase one 2025 CX260 Excavator, one 2025 Caterpillar Medium Duty Loader, and four Can Am Outlanders from Case Power & Equipment, Kelly Tractor, and Ameri-Recreational Sports, LLC respectively; and

WHEREAS, utilizing FSA23-EQU21.0, the City desires to purchase one 2025 Big Tex Utility Trailer from Right Trailers, Inc.; and

WHEREAS, the City Desires to issue a purchase order to Palmetto Ford of Miami utilizing FSA23-EQU21.1 to purchase one 2025 Ford F-650 Utility Truck with Crane; and

WHEREAS, utilizing FSA24-VEH32.0, the City desires to issue a purchase order to Bozard Ford Co. to purchase seventeen 2025 Ford Police Interceptor Unit SUVs, two 2025 Ford Police Responder Pick Up Trucks, four 2025 Ford F-350 Utility Trucks, two 2025 Ford Maverick Pick Up Trucks, one 2025 Ford T-350 Passenger Van, three 2025 Ford F-150 Pick Up Trucks, and one 2025 Ford Transit Cargo Van and to issue a purchase order to Garber Chevrolet Buick GMC, Inc. to purchase two 2024 Chevy Tahoe SUVs; and

WHEREAS, the City desires to issue a purchase order to Glade & Grove Supply Co Inc. utilizing Sourcewell RFP No. 0832923-AGCO to purchase two 2025 Case IH Farmhall Tractors; and

WHEREAS, the City desires to issue a purchase order to Tampa Crane utilizing Sourcewell RFP No. 093021-SWZ for the purchase of one 2025 Schwarze A4 Storm Street Sweeper; and

WHEREAS, utilizing Sourcewell RFP No. 091521-NAF, the City desires to purchase one 2025 Chevy

Equinox, two 2025 Chevy Blazer SUVs, five 2025 Toyota Highlander SUVs, and one 2025 Toyota Rav4 Hybrid from Alan Jay Chevrolet Cadillac and four 2025 Ford F-150 Pick Up Trucks with tow packages, three 2025 Ford F-250 Pick Up Trucks, and two 2025 Ford F-350 Utility Trane Trucks from Alan Jay Ford Lincoln Mercury; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interests of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

The foregoing recitals are hereby affirmed and ratified. Section 1.

The City Commission authorizes the City Manager to issue the purchase orders and take Section 3. any and all actions necessary to effectuate the intent of this Resolution.
