ORDINANCE NO. 18-24: AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AMENDING CHAPTER 33, "POLICE AND FIRE-RESCUE DEPARTMENTS", OF THE CODE OF ORDINANCES OF THE CITY OF DELRAY BEACH, FLORIDA, BY AMENDING "POLICE OFFICERS' RETIREMENT SYSTEM," SECTION 33.65, "ADMINISTRATION"; AMENDING "FIREFIGHTERS' RETIREMENT SYSTEM," SECTION 33.79, "ADMINISTRATION"; PROVIDING FOR STAGGERED TERMS FOR TRUSTEES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH, PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE. - d. Section 633.202, Florida Statutes, relating to the Florida Fire Prevention Code.

The proposed Ordinance amendment is presented to allow staggered terms for the two elected and two appointed Trustee positions on both the Firefighters' Retirement System Board of Trustees and Police Officers' Retirement System Board of Trustees so that the four respective positions are not up for election and appointment on the same date every four years.
