AGREEMENT BETWEEN THE DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY

AND JERK & LIME AT NICOLE'S HOUSE ("First Amendment") is made and entered into as of the ____ day of ______, 2024, by and between the DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY, a Florida public body, corporate and politic created pursuant to Section 163, Part III, Florida Statutes, (hereinafter referred to as the "CRA"), and JERK & LIME AT NICOLE'S HOUSE, a Florida limited liability company (hereinafter referred to as "LESSEE").

WITNESSETH:

WHEREAS, the CRA and the GRANTEE previously entered into a Site Development Assistance Funding Agreement dated January 24, 2023, (the "Original Agreement"); and

WHEREAS, the CRA and the LESSEE entered into a First Amendment to the Original Agreement in order to extend the Termination Date from July 31, 2023 to January 31, 2024.

WHEREAS, the CRA and the LESSEE desire to enter into a Second Amendment to the Original Agreement in order to extend the Termination Date from July 31, 2023 to February 29, 2024.

NOW THEREFORE, in consideration of the promises, mutual covenants, provisions, and undertakings hereinafter contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. That the recitals set forth above are true and correct and are incorporated herein by reference.
- 2. That the Termination Date is hereby extended from January 31, 2024 to February 29, 2024.

- 3. That except as amended herein, the CRA and LESSEE ratify, approve, and reaffirm the terms of the Original Agreement and the First Amendment and the Original Agreement and the First Amendment shall remain in full force and effect, except as amended herein.
- 4. In the event of any conflict or ambiguity by and between the terms and provisions of the Original Agreement, the First Amendment, and this Second Amendment, this Second Amendment shall control to the extent of any such conflict or ambiguity.
