

ORDINANCE NO. 07-26

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AMENDING THE LAND DEVELOPMENT REGULATIONS OF THE CITY OF DELRAY BEACH CODE OF ORDINANCES CHAPTER 7, "BUILDING REGULATIONS," ARTICLE 7.9, "DOCKS, DOLPHINS, FINGER PIERS, AND BOAT LIFTS," BY REPEALING AND REPLACING ARTICLE 7.9 TO PROVIDE UPDATED REGULATIONS FOR THE USE; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE, AUTHORITY TO CODIFY, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Land Development Regulations ("LDR") of the City of Delray Beach ("City") Code of Ordinances provides authority for the City Commission to amend, change, supplement, or repeal the LDR from time to time; and

WHEREAS, the existing regulations governing docks, dolphins, finger piers, and boat lifts do not allow for clear interpretation by staff and members of the public; and

WHEREAS, the existing regulations lack flexibility for the varying waterway conditions in the City and are often inconsistent with the regulations of the agencies having jurisdiction over the City's waterbodies which frequently results in requests for relief; and

WHEREAS, Ordinance No. 07-26 proposes new regulations for docks, piling, finger piers, boat lifts, and marinas that allow for safe navigation and reasonable access to all waterways within the city, by providing clear standards for the construction of docks, pilings, finger piers, boat lifts and other marine appurtenances that accommodate diverse waterway conditions and are consistent with the regulations of agencies with jurisdiction over the City's waterbodies; and

WHEREAS, pursuant to Florida Statutes 163.3174(4), the Planning and Zoning Board for the City of Delray Beach, sitting as Local Planning Agency, considered Ordinance No. 07-26 (as Ordinance No. 12-25) at a public hearing on November 17, 2025, and voted 7 to 0 to recommend that the proposed text amendments be approved, finding that the request and approval thereof is consistent with the Comprehensive Plan and meets the criteria set forth in the Land Development Regulations; and

WHEREAS, the City Commission has considered Ordinance No. 07-26 and the respective findings as set forth in the Comprehensive Plan and Land Development Regulations.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The recitations set forth above are incorporated herein.

Section 2. The City Commission of the City of Delray Beach finds the Ordinance is consistent with the Comprehensive Plan, meets the criteria set forth in the Land Development regulations, and is in the best interest of the City.

Section 3. Article 7.9, “Docks, Dolphins, Finger Piers, and Boat Lifts,” of the Land Development Regulations of the City of Delray Beach, Florida as provided in Exhibit A is hereby repealed in its entirety and replaced in its entirety with a new Article 7.9 provided in Exhibit B.

Section 4. All ordinances or parts thereof in conflict herewith be and the same are hereby repealed.

Section 5. Should any section or provision of this ordinance or any portion thereof, any paragraph, sentence, or word be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remainder hereof as a whole or part thereof other than the part declared to be invalid.

Section 6. Specific authority is hereby given to the City Clerk to codify this Ordinance.

Section 7. This Ordinance shall become effective immediately upon its passage on second and final reading.
