

**SECOND AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN
THE CITY OF DELRAY BEACH AND THE
DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY
FOR FUNDING CONSTRUCTION/PROFESSIONAL SERVICES
FY 2017-2018**

THIS SECOND AMENDMENT TO THE INTERLOCAL AGREEMENT FOR FUNDING OF CONSTRUCTION/PROFESSIONAL SERVICES FY 2017-2018 ("SECOND AMENDMENT") is made this _____ day of _____, 2018, by and between the **CITY OF DELRAY BEACH**, a Florida municipal corporation, (hereinafter referred to as "**CITY**"), and the **DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY**, a public body corporate and politic, duly created and operated pursuant to Chapter 163, Florida Statutes (hereinafter referred to as the "**CRA**").

WITNESSETH:

WHEREAS, the **CITY** and the **CRA** entered into an Interlocal Agreement for the Funding of Construction/Professional Services for Fiscal Year 2017-2018, on November 20, 2017 (the "Original Agreement"), which provided for funding for construction and professional services for projects within the Community Redevelopment Area; and

WHEREAS, the **CITY** and the **CRA** entered into the First Amendment to the Interlocal Agreement for the Funding of Construction/Professional Services for Fiscal Year 2017-2018 on April 5, 2018 (the "First Amendment"), which provided for funding increases based upon updated design costs, construction cost estimates, and/or actual construction costs; and

WHEREAS, the **CRA** and the **CITY** desire to enter into this Second Amendment in order to amend **Exhibit "A"** to the Original Agreement, as amended by the First Amendment in order to reflect the actual amount of funding provided by the **CRA** for the projects at the conclusion of Fiscal Year 2017-2018; and

WHEREAS, the funding is consistent with the **CRA's** Redevelopment Plan, and serves both a municipal and public purpose.

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the parties hereby agree as follows:

1. The recitations set forth above are hereby incorporated herein.
2. The **CRA** and the **CITY** agree to amend **Exhibit "A"** to the Original Agreement, as amended by the First Amendment in order to reflect the actual amount of funding provided by the **CRA** for the projects at the conclusion of Fiscal Year 2017-2018.
3. The **CRA** and the **CITY** agree that **Exhibit "A"** to the Original Agreement is hereby amended as provided in **Exhibit "A"**, which is attached to this Second Amendment, and incorporated herein by reference.

4. All other terms and conditions of the Original Agreement, as amended by the First Amendment, not in conflict with this Second Amendment shall remain in full force and effect.
