1. CALL TO ORDER:

The meeting was called to order at 5:39 p.m.

2. ROLL CALL/INTRODUCTIONS

Roll call of members present was conducted.

3. PLEDGE OF ALLEGIANCE TO THE FLAG

The Pledge of Allegiance was recited.

4. APPROVAL AND/OR ADDITIONS TO THE AGENDA:

A motion was made by Ms. Ann Stacy Wright to approve the agenda, seconded by Mr. Paul Cannon. Said motion passed unanimously.

5. APPROVAL OF THE MINUTES OF THE FEBRUARY 5, 2025, MEETING

A motion was made by Mr. Paul Cannon to approve minutes of the February 5, 2025, meeting, as corrected, seconded by Ms. Stacey Wright. Said motion passed unanimously.

6. PUBLIC COMMENTS:

Mr. Willie Potts residing at 600 Lindell Blvd. Apt. 107A, Delray Beach, FL 33444, made a comment regarding administrative complaints.

7. NEW BUSINESS

A. Chief of Police Update

Interim Chief Hunter provided the board with an update on Part One crimes.

- There are two homicides year to date. One has been cleared, and the second homicide is being actively investigated.
- There were 10 sex crimes incidents year-to-date in 2024 and 12 sex crimes in year to date in 2025, a 20% increase.
- A total of two roberries in April of 2024 and no robberies in April of 2025. In 2024 there were 13 robberies year to date, and three robberies in 2025 year-to-date, a 76.92 % decrease.
- A total of 19 aggravated assaults/battery incidents in April of 2024, and 11 in April of 2025, a 42.11% decrease. In 2024 there were 63 aggravated assaults/battery incidents year-to-date, and 43 were reported in 2025 year-to-date, a 31.75% decrease.
- Overall, persons crime incidents decreased by 30.23%
- A total of 16 burglary incidents in April of 2024, and 10 burglary incidents in April of 2025, a 37.50% decrease.
- A total of 148 larceny incidents in April of 2024, and 107 incidents in April of 2025, a 27.70% decrease. In 2024 there were 530 larceny incidents year-to-date, and 425 incidents were reported in 2025, year-to-date, a 19.81% decrease.
- A total of 16 vehicle theft incidents in April of 2024, and five vehicle incidents in April of 2025, a 68.75% decrease. In 2024 there were 63 vehicle theft incidents year-to-date, and 32 incidents were reported in 2025 year-to-date, a 49.21% decrease.
- Overall, the property crime incidents decreased by 22.76%.
- Overall, a decrease of 23.65% for both persons and property crimes.

Interim Chief Hunter provided members of the board with a brief overview of the Internal Affairs Monthly report for May 2025. There was a total of 11 internal and one external investigation initiated, for a total of 14 cases in 2025. In 2024, from January to May, a total of 16 investigations were initiated (10 internal and 6 external).

Current and previous year comparison of Coaching cases:

- Cases opened January 1, 2025 May 31, 2025 = 6 5 internally and 1 externally initiated
- Cases opened January 1, 2024- May 31, 2024 = 9 9 internally and 0 externally initiated

Current and previous year comparison of Merit Review cases:

- Cases opened January 1, 2025 May 31, 2025 = 11 4 internally and 7 externally initiated
- Cases opened January 1, 2024 -May 31, 2024 = 8 1 internally and 7 externally initiated

Current and previous year comparison of Training cases:

- Cases opened January 1, 2025 -May 31, 2025 = 1 0 internally and 1 externally initiated
- Cases opened January 1, 2024 May 31, 2024 = 2 2 internally and 0 externally initiated

Detective Todd Clancy provided members of the board with an update on cold case investigations.

C. VOLUNTEER PROGRAM OVERVIEW

Major Barry Tanteleff provided members of the board with an overview of the Volunteer Program.
