AN ORDINANCE OF THE CITY COMMIS-SION OF THE CITY OF DELRAY BEACH, FLORIDA, AMENDING THE LAND DEVEL-OPMENT REGULATIONS OF THE CITY OF DELRAY BEACH CODE OF ORDINANCES, CHAPTER 4, "ZONING REGULATIONS," ARTICLE 4.6, "SUPPLEMENTAL DISTRICT REGULATIONS," SECTION 4.6.16, "LAND-SCAPE REGULATIONS," SUBSECTION (I), "MINIMUM MAINTENANCE REQUIRE-MENTS," TO REMOVE EXISTING FERTIL-IZER USE REGULATIONS AND TO CREATE A NEW SUBSECTION (J), "FERTILIZER MANAGEMENT," TO ESTABLISH NEW FERTILIZER USE REGULATIONS AND ASSO-CIATED DEFINITIONS PURSUANT TO THE REQUIREMENTS OF FLORIDA STATUTES; PROVIDING A CONFLICTS CLAUSE, A SEV-ERABILITY CLAUSE, AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE AND FOR OTHER PURPOSES.
