QUESTIONS AND RESPONSES:

Q1. Do you have any drawings that show the floor plan and striping layout for the parking spaces?

R1. Yes. Exhibit B has been added per this Addendum No. 2.

Q2. The RFP states that part or all of the ground floor parking area is separated from the rest of the facility. Does this area contain spaces that are allocated for other users? If so, how is this area protected or enforced? Could the spaces be used for general public parking during other hours of the day or week?

R2. This area contains 17 general public parking spaces that are paid for via parking meters and enforced by license-plate recognition (LPR) technology, as is the rest of the garage. The parking garage is open 24 hours per day, seven days per week.

Q3. Does the roof top deck contain light poles? If so, how many?

R3. Yes. There are six light poles on the top (roof) floor of the parking garage.

Q4. Does the City have architectural drawing of the facility?

R4. Yes. Please refer to Exhibit A, Old School Square Parking Garage Plans added per Addendum No. 1. Additional drawings have been added per this Addendum No. 2 to assist Proposers.

NOTE: Items that are ~~struck through~~ are deleted. Items that are underlined have been added. All other terms and conditions remain as stated in the solicitation.

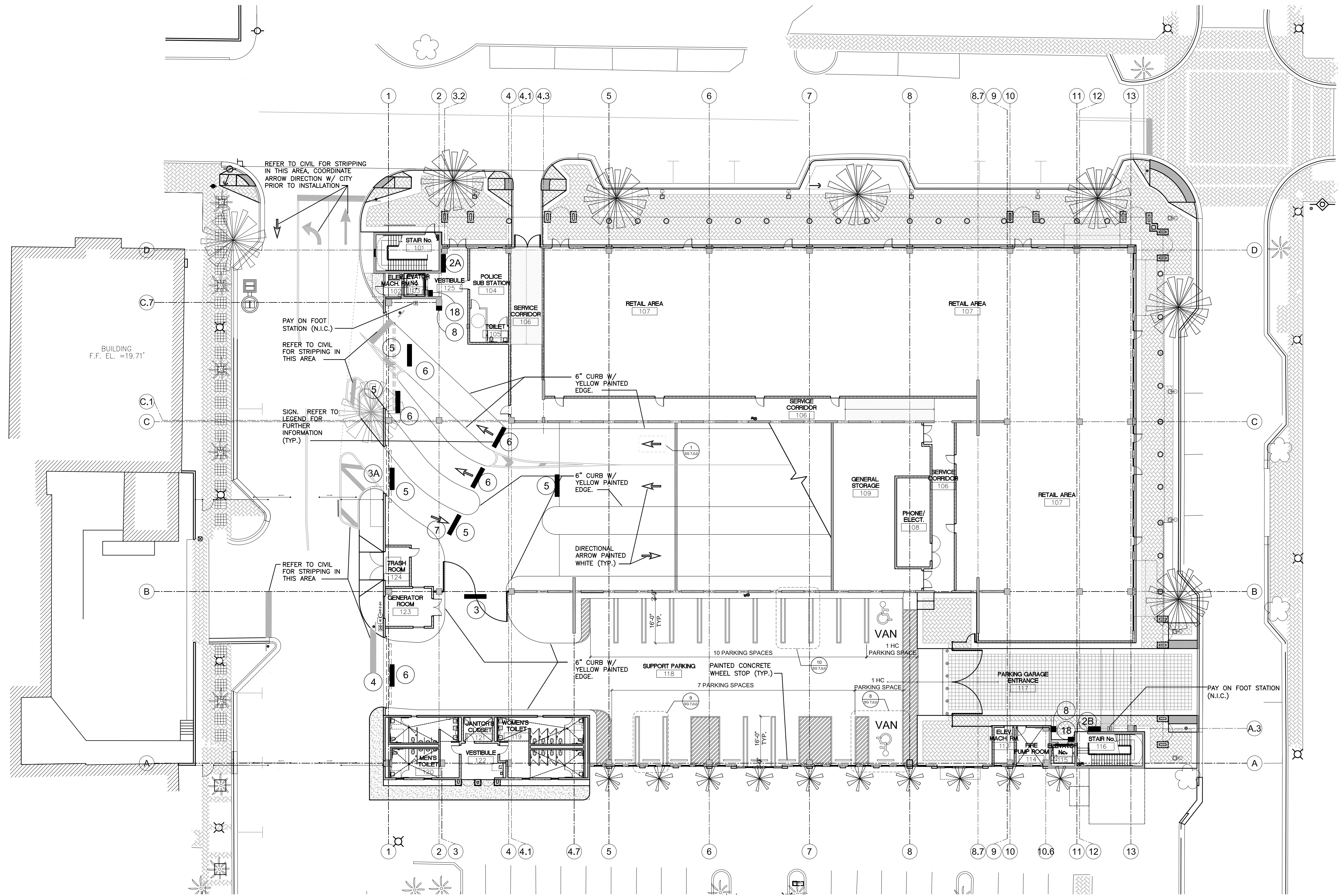

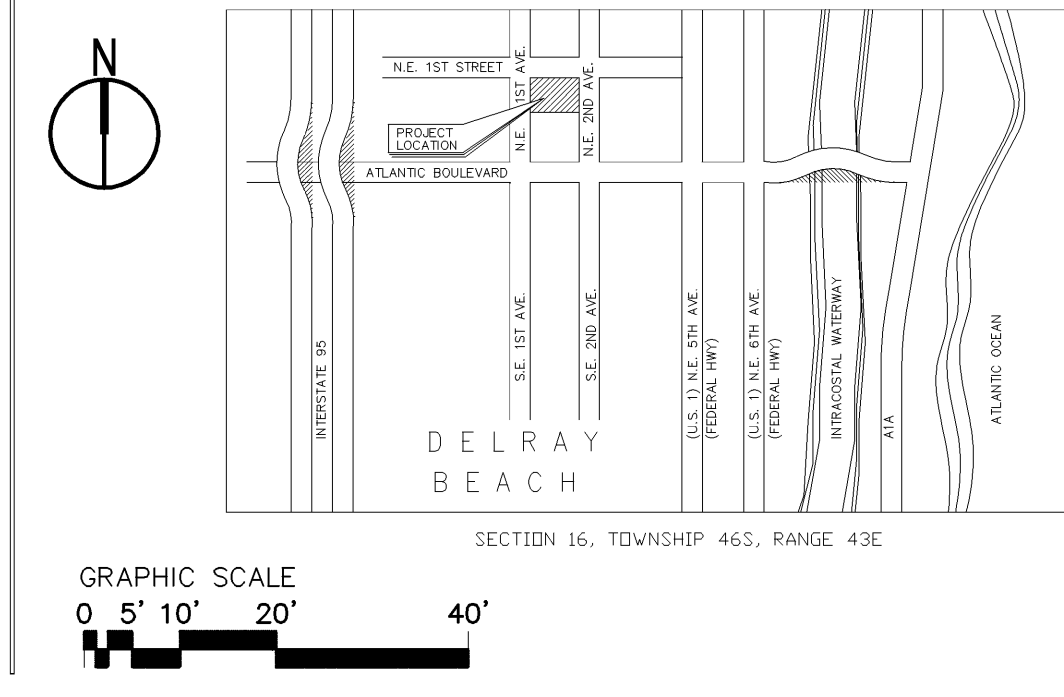

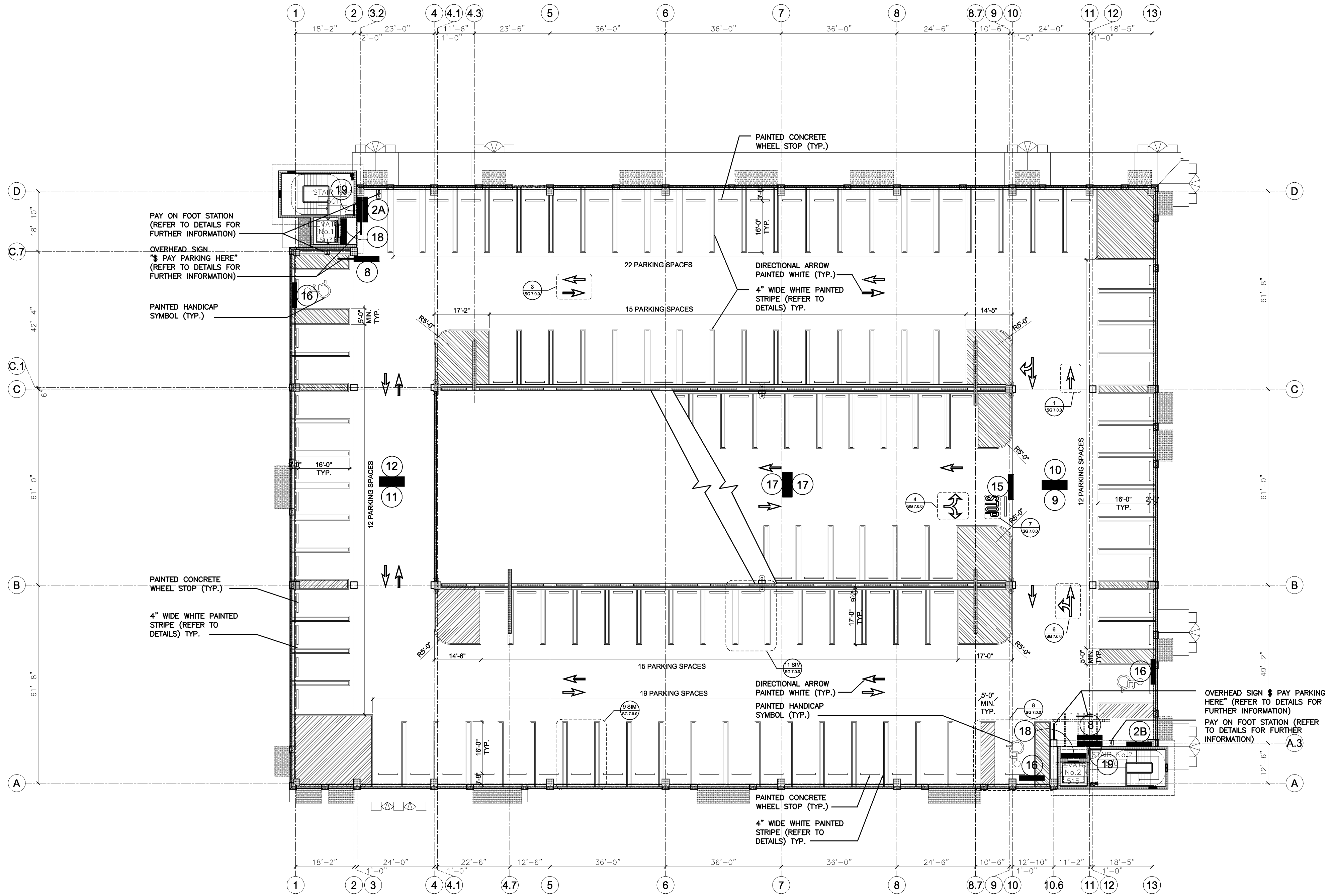
