

**SECOND AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN
THE CITY OF DELRAY BEACH AND THE
DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY
FOR FUNDING CONSTRUCTION/PROFESSIONAL SERVICES
FY 2021-2022**

THIS SECOND AMENDMENT TO THE INTERLOCAL AGREEMENT FOR FUNDING OF CONSTRUCTION/PROFESSIONAL SERVICES ("SECOND AMENDMENT") is made this _____ day of November, 2022, by and between the **CITY OF DELRAY BEACH**, a Florida municipal corporation, (hereinafter referred to as "**CITY**"), and the **DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY**, a public body corporate and politic, duly created and operated pursuant to Chapter 163, Florida Statutes (hereinafter referred to as the "**CRA**").

W I T N E S S E T H:

WHEREAS, the **CITY** and the **CRA** entered into an Interlocal Agreement for the Funding of Construction/Professional Services for Fiscal Year 2020-2021, dated March 1, 2022 (the " Agreement"), which provided for funding for construction and professional services for projects within the Community Redevelopment Area; and

WHEREAS, the **CITY** and **CRA** entered into a First Amendment to the Agreement, dated August 9, 2022, ("First Amendment"), to transfer Thirty-Thousand and 00/100 Dollars (\$30,000.00) from the Osceola Park Neighborhood Improvements Phase 1 project to the NE 3rd Street/Avenue Improvements project; and

WHEREAS, the **CITY** and the **CRA** desire to enter into this Second Amendment in order to amend **Exhibit "A"** to the Agreement to provide for adjustments to project costs; and

WHEREAS, the **CITY** and the **CRA** find that this Second Amendment serves a municipal and public purpose, is consistent with the Community Redevelopment Plan, and the requirements of Chapter 163, Florida Statutes.

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the parties hereby agree as follows:

1. The recitations set forth above are hereby incorporated herein.
2. **Exhibit "A"** to the Original Agreement is replaced in its entirety with the attached **Exhibit "A"**, incorporated herein by reference.
3. All other terms and conditions of the Agreement and First Amendment not in conflict with this Second Amendment shall remain in full force and effect.
