

RESOLUTION NO. 214-25

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH SAMSARA INC., FOR FLEET MANAGEMENT INFORMATION SYSTEMS AND RELATED SOFTWARE AND HARDWARE SOLUTIONS UTILIZING SOURCEWELL'S, REQUEST FOR PROPOSALS NO. 102924; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS AND/OR RENEWALS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (the "City") is authorized to enter into agreements to provide products and services in accordance with its Charter; and

WHEREAS, the City requires fleet management information systems and fleet related software and hardware; and

WHEREAS, Sourcewell administers a Cooperative Purchasing Program wherein it performs solicitations for a multitude of products and administers the resulting contracts; and

WHEREAS, contracts solicited by Sourcewell are accessible to state government entities and other public entities located in the United States and Canada; and

WHEREAS, Sourcewell issued Request for Proposals (RFP) No. 102924 for fleet management technologies with related software solutions; and

WHEREAS, in accordance with RFP No. 102924, Sourcewell entered into Contract No. 102924-SAM with Samsara Inc. ("Contractor"); and

WHEREAS, the City desires to obtain the aforementioned products from Contractor by utilizing Contract No. 102924-SAM; and

WHEREAS, in accordance with Section 46 of the City's Purchasing Policies and Procedures Manual, the City Manager or City Commission shall have the authority to join with other units of government in cooperative purchasing plans, as applicable in accordance with the purchasing criteria set forth herein; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves this Agreement between the City and Contractor attached hereto and incorporated herein as Exhibit “A”.

Section 3. The City Commission authorizes the City Manager to execute any amendments and/or renewals and take any and all actions necessary to effectuate the intent of this resolution.

Section 4. This Resolution shall become effective immediately upon its passage and adoption.
