A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH UKG KRONOS SYSTEMS, LLC, FOR WORKFORCE MANAGEMENT SYSTEMS AND RELATED PRODUCTS, SERVICES, AND SOLUTIONS UTILIZING COBB COUNTY, GEORGIA REQUEST FOR PROPOSAL 24-6833; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS THERETO AND TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide products and services in accordance with its Charter; and

WHEREAS, the City requires workforce management systems and related products, services, and solutions; and

WHEREAS, Cobb County, Georgia, in partnership with Omnia Partners' Cooperative Purchasing Program, issued Request for Proposal No. (RFP) 24-6833 to obtain workforce management systems and related products, services, and solutions; and

WHEREAS, in accordance with RFP 24-6833, Cobb County entered into an agreement with UKG Kronos Systems, LLC ("Contractor"); and

WHEREAS, the City desires to obtain the aforementioned products and services by utilizing an existing agreement with Contractor pursuant to Cobb County RFP 24-6833; and

WHEREAS, in accordance with Section 36 of the City's Purchasing Policies and Procedures Manual, piggybacking on State, County, other municipalities, and other government entity bids is permitted within the approval thresholds of the City Manager or City Commission, as applicable in accordance with the purchasing criteria set forth herein; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

- Section 1. The foregoing recitals are hereby affirmed and ratified.
- <u>Section 2.</u> The City Commission of the City of Delray Beach has reviewed and hereby approves this Agreement between the City and Contractor, attached hereto and incorporated herein as Exhibit "A".
- <u>Section 3</u>. The City Commission authorizes the City Manager to execute any amendments and take any and all actions necessary to effectuate the intent of this Resolution.
