RESOLUTION NO. 184-23

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AUTHORIZING A SPECIAL EVENT SPONSORSHIP IN AN AMOUNT NOT TO EXCEED \$10,000 FOR THE SPECIAL EVENT KNOWN AS THE MUSCLE ON THE BEACH CAR SHOW; AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

WHEREAS, the City Commission desires to sponsor special events in the City of Delray Beach that provide a public purpose in alignment with the City's Special Events Policy; and

WHEREAS, the City of Delray Beach, Florida received a Special Event Sponsorship Request from George Walden DBA Muscle on the Beach (the "Applicant") requesting the City to sponsor the Muscle on the Beach Car Show (the "Special Event") to be held on March 2, 2024 on the Old School Square Campus; and

WHEREAS, the Applicant has requested a waiver of all costs related to the provision of City services for the event minus any direct costs to the City, currently estimated at \$8,664.64; and

WHEREAS, the Applicant provided a Statement of Public Purpose, attached hereto and incorporated herein as Exhibit "A", which anticipates a profit in the amount of a \$25,000 to be donated to the Sandoway Discovery Center, a Delray Beach-based, non-profit organization; and

WHEREAS, the City Commission has reviewed the submitted Special Event Sponsorship Request application and considered whether the Special Event will provide a public purpose that is in alignment with the Special Events Policy.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> The above recitals are incorporated as if fully set forth herein.

<u>Section 2.</u> The City Commission has considered the request for sponsorship and finds that the Muscle on the Beach Car Show to be held on March 2, 2024 provides a public benefit consistent with the City's Special Event Policy.

Section 3. The City Commission approves the request for sponsorship submitted by George Walden DBA Muscle on the Beach in an amount not to exceed \$10,000.					
with th	Section 4. The City Commission authorizes the City Manager to execute an agreement consistent with the approval herein and to take any and all actions necessary to effectuate the intent of this Resolution.
