AN ORDINANCE OF THE CITY COMMIS-SION OF THE CITY OF DELRAY BEACH, FLORIDA, AMENDING THE LAND DEVEL-OPMENT REGULATIONS OF THE CITY OF DELRAY BEACH CODE OF ORDINANCES CHAPTER 2, "ADMINISTRATIVE PROVI-SIONS," ARTICLE 2.4, "DEVELOPMENT APPLICATION REQUIREMENTS," SEC-TION 2.4.11, "RELIEF," SUBSECTION (E), "REQUESTS FOR ACCOMMODATION," TO REQUIRE A REASONABLE ACCOMMODA-TION REQUEST BE SUBMITTED IN WRIT-ING, TO MODIFY THE AMOUNT OF TIME TO REQUEST ADDITIONAL INFORMATION AND TO MAKE A FINAL DETERMINATION, TO REQUIRE ANY DENIAL OF A REASONABLE ACCOMMODATION REQUEST TO STATE OBJECTIVE, EVIDENCE-BASED REASONS FOR THE DENIAL, TO COMPORT WITH RECENT CHANGES TO STATE LAW; PRO-VIDING A CONFLICTS CLAUSE; A SEVER-ABILITY CLAUSE; AUTHORITY TO CODIFY; PROVIDING AN ÉFFECTIVE DATE, AND FOR OTHER PURPOSES.
