Follow up on Achieving Goals Using Impact Driven Evaluation (A.-G.U.I.D.E.) Funding Agreement Old School Square Center For The Arts, Inc.



At the **February 22, 2022**, CRA Board Meeting, the Board approved the following:

- 1) Issue the OSSCA a formal written notice of deficiency(ies) and opportunity to cure pursuant to the AG.U.I.D.E. Funding Agreement; and (Issued on 2/23/22)
 - * Received on February 24, 2022
 - * **14** Day Deadline March 10, 2022
- 2) Issue the OSSCA reasonable notice for the CRA to access and examine all records, books, papers, or documents relating to the funding provided pursuant to the A-G.U.I.D.E. Funding Agreement; and (Issued on 2/23/22)
- 3) Should OSSCA fail to cure the deficiency(ies) to the <u>satisfaction of the CRA</u>, within fourteen (14) days from receipt of the Notice of Deficiencies, CRA Staff shall then issue written notice to the OSSCA that the A-G.U.I.D.E. Funding Agreement is deemed immediately voided and notice that the CRA is entitled to recoup the portion of funds the CRA allocated and/or already disbursed to OSSCA pursuant to the AG.U.I.D.E. Funding Agreement; and
- 4) The CRA's Chair, Executive Director and legal counsel may execute any and all related documents and take all necessary action to facilitate the above action(s).



- The CRA Board also directed CRA Staff to submit a Freedom of Information Act Request to the US Small Business Administration regarding the Paycheck Protection Program. (Requested on 2/25/22)
 - SBA estimated response date to FOIA Request 3/28/22
- CRA Staff also sent OSSCA a written public records request for document with a March 15, 2022 deadline. (Requested on 2/25/22)
- To Date:
 - The CRA has not received all the information or documents requested in the Notice of Deficiency by the 14-day cure period (Deadline of March 10, 2022) from OSSCA and the information the OSSCA has submitted is insufficient for the CRA to fully evaluate OSSCA's performance, financial status, and to determine if the expenditure of funds is in accordance with the A-G.U.I.D.E. Funding Agreement.
 - On March 15, 2022, CRA Staff received a thumb drive from OSSCA



- 1. Deem Old School Square Center for the Arts, Inc. ("OSSCA or OSS") has failed to cure the deficiency(ies) to the satisfaction of the CRA as set forth in the Notice of Deficiencies dated February 23, 2022 and pursuant to the Achieving Goals Using Impact Driven Evaluation ("A-G.U.I.D.E.") Funding Agreement dated October 16, 2020 ("A-G.U.I.D.E. Funding Agreement");
- 2. Issue OSSCA formal written notice that the A-G.U.I.D.E. Funding Agreement is immediately voided;
- 3. Authorize the recoupment of the funding amount allocated for fiscal year 2020-2021 and disbursed by the CRA to OSSCA for the first quarter of the fiscal year 2020 2021 in the amount of One Hundred Eighty-Seven Thousand Five Hundred and 00/100 Dollars (\$187,500.00) by issuing a fifteen (15) days demand letter; and
- 4. Authorize the CRA's Chair, Executive Director and legal counsel to execute any and all related documents.




