



General Maintenance



- Litter removal.

Electricians

Landscape Enhancement Projects In Progress




- NW/SW 5th Avenue







Other Non-Profit Relationships

The Police Department and Aid to Victims of Domestic Violence (AVDA) has a formal partnership agreement.

The agreement outlines basic responsibilities of both parties but there is no cost to the City for these services. Agreement essentially states that AVDA will provide certain services to those in Delray Beach in need and Police should refer these persons to them if they are in need of those services. Additionally, it requires AVDA to maintain required statutorily required records or to turn them over to the City for keeping.

Other Non-profits informally provide services to persons in need whom are referred by the Police. However, No other formal agreements are known to staff at this time.
