Project Description: provide a brief overview of the proposed project concept and design needs: The proposal consists of the following to accommodate an approximately 600 sf outdoor dining area along the east and south sides of the existing Ziree Thai & Sushi Restaurant: 1. Removal of a portion of the steps along the south side of the property and installation a retaining wall with railing to establish a dining area; 2. Removal of a portion of the existing planter along the east side of the property and installation of a paver brick outdoor seating/dining area, replacement of the 2 trees with Cathedral Oak trees and upgrades to the remaining planter area; 3. Removal of 8 existing awnings and installation of 2 black shed style awnings at the dining areas and 1 at the entrance.


