

ORDINANCE NO. 09-22

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, REZONING APPROXIMATELY 0.183 ACRES OF LAND PRESENTLY ZONED SINGLE FAMILY RESIDENTIAL (R1) DISTRICT TO COMMUNITY FACILITIES (CF) DISTRICT FOR A PARCEL LOCATED AT 620 LAKE IDA ROAD, AS MORE PARTICULARLY DESCRIBED HEREIN; AMENDING THE “CITY OF DELRAY BEACH, ZONING MAP, JULY 6, 2021”; PROVIDING A CONFLICTS CLAUSE AND A SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, Community Child Care Center of Delray Beach Inc., (“Owner”) is the owner of the property located at 620 Lake Ida Road located on the south side of Lake Ida Road between NW 10th Avenue and NW 4th Street with a Parcel Control Number of 12-43-46-08-21-005-0030 (“the Property”); and

WHEREAS, the Property, measuring approximately 0.183 acres, as more particularly described in Exhibit “A”, Legal Description, and Exhibit “B”, Proposed Zoning, is shown on the City of Delray Beach Zoning Map, dated July 6, 2021, as zoned Single Family Residential (R1) District (“R1 District”) with a Land Use Map designation of Low Density; and

WHEREAS, the Owner designated David Schmidt of Simon and Schmidt, PA (“Applicant”) to act as its agent; and

WHEREAS, the Applicant requested a rezoning of the Property from R1 District to Community Facilities (CF) District; and

WHEREAS, pursuant to Florida Statutes 163.3174(4)(c), the Planning and Zoning Board for the City of Delray Beach, sitting as Local Planning Agency, considered this item at a public hearing on April 18, 2022 and voted 6 to 0 (with Ms. Morrison absent) to recommend that the Property be rezoned to Community Facilities, finding that the request and approval thereof is consistent with the Comprehensive Plan, meets the criteria set forth in the Land Development Regulations, and is in the best interest of the City; and

WHEREAS, the City Commission of the City of Delray Beach finds the designation of Community Facilities zoning appropriate for the Property and in the best interest of the City; and

WHEREAS, it is appropriate that the Zoning District Map of the City of Delray Beach, Florida, be amended to reflect the revised zoning classification.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The recitations set forth above are incorporated herein.

Section 2. The Zoning District Map of the City of Delray Beach, Florida, upon the effective date of this Ordinance, be, and the same is, hereby amended to reflect a zoning classification of Community

Facilities for the Property described in Exhibit “A”, Legal Description, as shown on the map in Exhibit “B”, Proposed Zoning, attached hereto and incorporated herein.

Section 3. All ordinances or parts thereof or parts of the Code conflicting or inconsistent with the provisions of this Ordinance are hereby repealed.

Section 4. If any word, clause, sentence, paragraph, section, or part thereof contained in this Ordinance is declared to be unconstitutional, unenforceable, void, or inoperative by a court of competent jurisdiction, such declaration shall not affect the validity of the remainder of this Ordinance.

Section 5. This Ordinance shall become effective upon approval at second reading. No development orders, development permits, or land uses dependent on this amendment may be issued or commence before it has become effective.

LEGAL DESCRIPTION

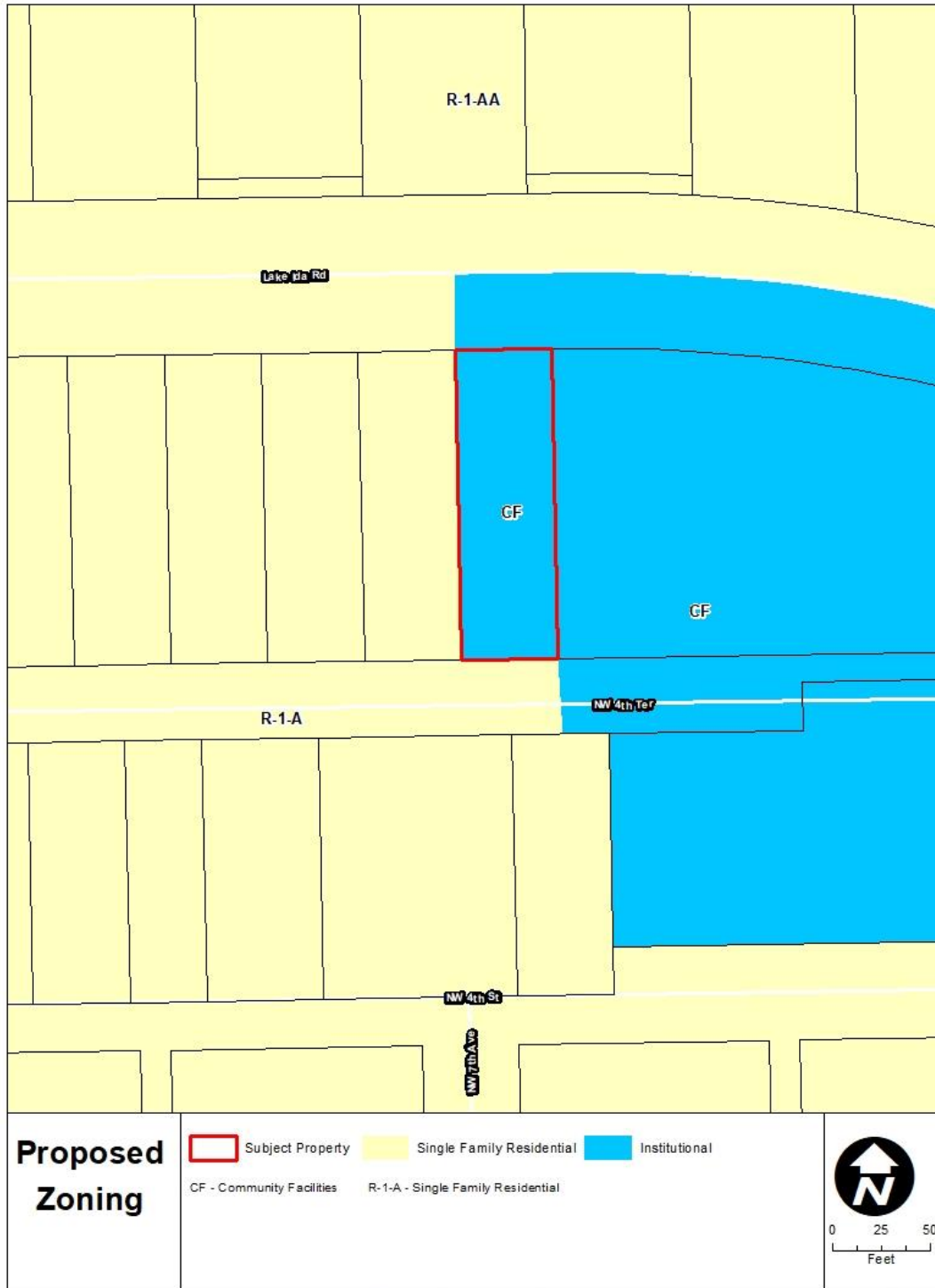
620 Lake Ida Road - PCN 12-43-46-08-21-005-0030
