This **AMENDMENT NO. 02**, is entered into on ________to that Agreement dated December 12, 2019, and as amended on June 8, 2021 (A1), between "the Parties," the South Florida Water Management District (District), and City of Delray Beach (Recipient).

Background

- 1. The Governing Board of the District, at its December 12, 2019 meeting, approved entering into this Agreement with the Parties for Alternative Water Supply Reclaimed Water Main Construction along SW 4th Street.
 - 2. The term of the Agreement was Five Hundred and Sixty-Six (566) days.
- 3. The Parties amended the Agreement to extend the period of performance, revise the Statement of Work, and revise the Payment and Deliverable Schedule (A1) of the Agreement.
- 4. The Parties wish to amend the Agreement to extend the period of performance, revise the Statement of Work, Payment and Deliverable Schedule, Quarterly Status Report, and Final Project Status Report of the Agreement.

Terms and Conditions

- 5. The term of the Agreement is hereby extended by one (1) year and the expiration date, as amended, is June 30, 2023. Regardless of the actual date of execution, this **AMENDMENT NO. 02** shall be effective as of July 1, 2022.
- 6. The Statement of Work, attached as Exhibit "A1" to the Agreement, is hereby amended by revising "Work Breakdown Structure" as set forth in Exhibit "A2", attached hereto and made a part of this **AMENDMENT NO. 02**.

- 10. All other terms and conditions of the Agreement remain unchanged.

EXHIBIT "A2" STATEMENT OF WORK

Reclaimed Water Main Construction along SW 4th Street City of Delray Beach

A. INTRODUCTION/BACKGROUND

The City of Delray Beach (City or Recipient) established alternative water supply goals in conjunction with their South Florida Water Management District (District) Water Use Permit. Implementation of the City's reclaimed water system will provide an alternative water supply and reduce demands on both the surficial aquifer and on their potable water system.

Delray Beach's Reclaimed Water Master Plan Update, completed in December 2016, identified Area 14 as the ninth project of the City's total reclaimed water system, which will provide up to 0.21 million gallons per day (mgd) of additional reclaimed water use. The City plans to implement other projects identified in the Master Plan Update on a continual basis over the next 8 years, and the total program will provide up to 5.1 mgd of reclaimed water available for the entire system. The Reclaimed Water Master Plan Update is consistent with the City's comprehensive plan, which specifically encourages more reuse of effluent from the South-Central Regional Wastewater Treatment Plant to reduce the demands on the potable water system.

B. OBJECTIVES

The objective of this project is to install reclaimed water pipeline within Area 14 of the City's Reclaimed Water Master Plan, thus providing an additional 0.21 mgd of additional reclaimed water use and continuing the expansion of the City's reclaimed water system.

C. SCOPE OF WORK




Figure 1. Proposed reclaimed water pipeline

Construct approximately 10,270 linear feet of reclaimed water pipeline in the area along SW 4th Street from SE 1st Avenue to SW 4th Avenue. The reclaimed water pipeline will be 12-inch diameter along SW 4th Street. The remainder of the reclaimed water pipeline will be between 4-and 8-inch diameter (**Figure 1**). The reclaimed water pipeline will be routed west at the intersection of Auburn Avenue and Auburn Drive along the City's existing force main easement. The route will continue over to SW 6th Street where the reclaimed water service will be installed from the entrance to the back of the Catherine Strong Center/Boys & Girls Club for future connection. The route will continue along NE 2nd Street from NE 4th Avenue to NW 2nd Avenue.

The reclaimed water pipeline will be installed as a dry line with service stubs for the following future customers: Merritt Park, Catherine Strong Center/Boys & Girls Club, Delray Beach Cemetery, and Toussaint L'ouverture High School for the Arts and Village Academy for the Arts. The installation of the reclaimed water pipeline necessary to provide those customers is proposed for FY23.

- A summary deliverable schedule associated with this project is set forth below.
- The **Recipient** shall submit all deliverables to the **District's** project manager. All deliverables submitted hereunder are subject to review by the **District**. The **Recipient** hereby agrees to provide the **District** all deliverables, data and information described in the Statement of Work.
- Payment shall be made following receipt and acceptance by the **District** of the Reimbursement Request Package(s) in accordance with the schedule set forth below. The **Recipient** shall submit a reimbursement request upon completion of each Task noted below. If applicable, the **Recipient** shall submit a final reimbursement request package for payment and Exhibit "D2" on or before May 31, 2023 for reimbursement. All reimbursement request packages shall be accompanied by adequate documentation to demonstrate completion of each Task in accordance with Exhibit "A2" the Statement of Work (SOW).
- Reimbursement Request Packages shall include but not be limited to, a copy of **Recipient's** invoice, signed certification letter for partial payment that the task(s) is (are) complete per the SOW or that the project is complete per the SOW, Exhibit "D2" Final Project Summary Report, copies of vendor invoices and payments, and any other documentation supporting payment. Timely payment of invoices shall be contingent upon the District's review and acceptance of all invoice(s). Final payment is subject to the final project construction cost. The Reimbursement Request Package shall be submitted on or before May 31, 2023.
- The District shall only be obligated to pay for documented actual construction costs within the not-to-exceed amounts specified below. In the event actual construction costs by the Recipient are less than the not-to-exceed amount for a particular task, the Recipient shall have the right to apply the unexpended balance toward another task, unless the total current construction cost has decreased. The Recipient shall provide prior written notice of its decision to exercise this right to the District's Project Manager. If the Recipient does not exercise this right, the Recipient agrees to amend the contract to revise the approved funding consistent with the original percentage to the lower construction cost. In no event shall the District's total obligation exceed the amount specified below for the total Agreement; however, an actual construction cost less than the estimated construction cost may result in a reduced final payment. The Recipient is responsible for any additional funds either through local revenues, grants, other appropriations, and/or other funding sources.
- Total reimbursement payment by the **District** for all work completed herein <u>shall not exceed</u> the amount of \$450,000. If the total consideration for this **Agreement** is subject to multi-year funding allocations, funding for each applicable fiscal year of this **Agreement** will be subject to Governing Board budgetary appropriation. In the event the **District** does not approve funding for any subsequent fiscal year, this **Agreement** shall terminate upon expenditure of the current funding, notwithstanding other provisions in this **Agreement** to the contrary.
