A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING THE ISSUANCE OF A PURCHASE ORDER UTILIZING SOURCEWELL CONTRACT NO. 012418-ALT FOR THE PURCHASE OF A BUCKET TRUCK WITH CHIPPER BODY FOR TREE TRIMMING; AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO EFFECTUATE THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming and products in accordance with its Charter; and

WHEREAS, Sourcewell, formerly known as the National Joint Powers Alliance, is a public agency serving as a national municipal contracting agency with the authority to develop and offer cooperative procurement services to states, cities, counties, all government agencies, and non-profit organizations; and

WHEREAS, Sourcewell administers a National Cooperative Purchasing Program wherein it performs solicitations for a multitude of products and administers the resulting contracts; and

WHEREAS, Sourcewell issued Request for Proposal No. 012418 (Solicitation) for public utility equipment with related accessories and supplies; and

WHEREAS, pursuant to the Solicitation, Altec Industries, Inc., was awarded Contract No. 012418-ALT; and

WHEREAS, the City desires to purchase a bucket truck with chipper body to be utilized for tree trimming; and

WHEREAS, the City desires to issue a purchase order to Altec Industries, Inc., utilizing Sourcewell Contract No. 012418-ALT, to acquire the bucket truck with chipper body; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:
