Further discussion ensued about the payroll reporting issues that surfaced. It was explained that these issues came about from the Internal Auditor's investigation, therefore, a time and attendance program will be implemented.

Mr. Moore introduced Mr. Lanahan of the Treasure Coast Regional Planning Council who gave brief comments and feedback of the Charrette Workshop meeting held on June 23, 2022 concerning Old School Square. He reported there were approximately 70 people from the community who attended the Charrette.

He explained the three (3) primary questions that were covered at the Workshop. They were:

- 1. What activities and programs does the community desire to have at Old School Square?
- 2. Identify activities that would be inappropriate to the site.
- 3. Does your group feel that the activities are diverse enough to appeal to

all ages and backgrounds?

The community gave a list of do's and don'ts that they would like to see for the Old School Square site. The biggest takeaway was that they need to get the facility up to speed and the group of 70 people liked the activities that were once there.

Former Fire Chief Kerry Cohen spoke about a recognition monument for Alfred "Zack" Straghn for his heroic contributions in the City of Delray Beach especially bringing about civil rights on the public beach in Delray.

Ms. Margaret Bloom spoke about her displeasure of the Crest Theatre renovations.

Mr. Vinnie Gray and Sergeant Deen with the City of Delray Beach Police Department requested that the City Commission pull Item 9B in order to have a discussion and to clarify the language of the Ordinance that will affect the Police Officer's Retirement System.

Suzanne Boyd, Strategic Marketing Manager with the Downtown Development Authority, gave an update of some of the activities scheduled to take place in Downtown Delray Beach in the months of August and September. For additional information, she explained, anyone can visit www.Downtowndelraybeach.com and click on the events tab.

Price Patton expressed that he listened to the Historic Preservation presentation and urged the City Commission to move forward with the Frog Alley historic overlays, fast tracking historic preservation applications and urged the City Commission to give staff direction to move forward.

Arland Dominic, 50 East Road, Delray, expressed his appreciation for the presentation on the tree canopy. He stated Item 6. H. on the agenda regarding traffic planning and lane closures - more specifically regarding 601 Atlantic Avenue that lane closures on Atlantic Avenue are a nuisance and any future construction projects should provide for pedestrian right-of-ways. Finally, he felt Ordinance No. 99 in our Code provides for enforcement of noise control.

Chett Stably began speaking, but was interrupted due to Item 8A on the agenda was a public hearing item and must wait to be heard at that time.

Tom Warnkey, 2780 Worchester Road, Delray explained that he is the Archive Coordinator at the Delray Beach Historical Society and is also the Executive Director of the Surfing FL Museum. He is proposing that their museum exhibits be displayed in the Cornell Museum.

Vera Woodson, 1885 Palm Cove Blvd., spoke about a walkthrough that she had with Mr. Moore and his team to visit the west end of the downtown area to try to bring about an equitable investment on that side of town. She referenced a list of issues to be addressed.

Angie Gray, 3765 Riverside Way, Delray Beach, spoke about the Early Learning Coalition contract for after school care and camp that she brought up a couple of weeks ago. She is looking for an update that she requested. The issues were that 72 children are now in the program where at one time there used to be about 350 children from the community. She explained that now the space cannot be shared at the same time. She noted that the Community Center is a second location that is vacant each day and wondered why this type of program is in this City.

Mr. Moore asked Mr. Samuel Metott Director of Parks and Recreation to address the comments that Ms. Gray made. Mr. Metott explained that the summer camp program is a licensed program through Palm Beach County Department of Children Services. There are guidelines and procedures that must be adhered to in order to participate in the summer camp program which brings many benefits to the community.

Ms. Anthea Gianniotes, Development Services Director entered File No. 2022-065 into the record. The applicants Mr. Peter and Tom Carney gave brief testimony of the project. It was explained that this is a unicorn situation where the 1950's house is smaller than the ancillary structure. When the property was purchased by the owner, it was in complete disrepair. The reason for the waiver request is because the accessory structure exceeds the two LDR's in height and square footage. The primary home is 631 square feet and the ancillary is 342 which exceeds

the 40%. The property owner seeks to maintain the charm of Delray Beach Village by the Sea.

Mr. Tom Carney explained the 4 tests that the waiver must meet. He also explained that the applicant is trying to preserve the house without tearing it down. Due to the small size of the principal home, additional storage is understandable and that everything would be behind the fences and not able to be seen.

Ms. Anthea Gianniotes, Development Services Director explained that there are 2 waivers for the subject property. She explained that what is being called the primary structure may not have originally been the primary structure. It was also explained that it is extremely small and under the current LDR, a residential unit would be required to be at least 1000 square feet. She explained it was constructed in 1952 and in terms of the height, the shed is higher than the principle structure. According to LDR Section 4.3.4. (h) the city does not allow sensory structures to exceed the height of the principle structure.

Public comment was opened by Mayor Petrolia. There being no one present, public comment was closed.

Further discussion ensued.

Vice Mayor Frankel wished his brother Brett Frankel a happy birthday.

Commissioner Johnson shared sentiments of Deputy Vice Mayor Casale about getting something moving at the Old School Square Campus since the property has been vacated almost a year ago. Also in regards to the salary survey, she feels the Department Heads need to be apart of the salary study and what the requirements are for their individual departments. She reminded everyone that she had asked for an audit of the P-Card usuage and has since spoken to the Internal Auditor and moving forward would be a bit pre-mature since the OIG still has some dates outstanding, so she is asking for consensus to withdraw her request for the P-Card audit.

Mayor Petrolia clarified some points about the Crest Theatre that it is

not 80% complete, it has not been a year and that the City only accepted the premises back since February and could not move forward before that time. Also, the condition of the premises were not left as they were when it was given to them. Further the City is tied up in litigation which only complicates the matter more. In regards to the Mark Lauzier filing, the case was positive towards the City and the rumors of the \$200 transaction was actually a policy that the City has in place which allowed the purchase of the airline ticket for a family member in which she reimbursed the City for.

Mayor Petrolia briefly spoke about controversial issues that sometimes come up on an agenda that makes it uncomfortable for all involved. She apologized for her reaction to a situation that took place at the last meeting with a colleague. She asked that all parties remain civil with each other and act with respect.
