The CRA agrees to pay Employee for services rendered an annual salary of $\underline{\text{One}}$ $\underline{\text{Hundred Seventy-Four Thousand Three Hundred Twenty-Six}$ and 54/100 $\underline{\text{Dollars}}$ (\$___174,326.54____) payable bi-weekly, at the same time as other employees of the CRA are paid. The salary of a \$__174,326.54_ represents an adjustment of a 7% increase to the annual salary of $\underline{\$162,922.00}$ and is to be effective retroactively to June 29, 2022.

NOW THEREFORE, the EMPLOYER and CRA agree to the following amendment to

On an annual basis, The Board of Commissioners of the CRA shall engage in an annual performance evaluation and salary and benefit review of said Employee on or about June 29th, during the term of this Agreement for the purpose of recommending compensation and benefit adjustment for the ensuing year.

Except as modified by this Third Amendment, all terms, covenants, obligations and provisions of the Original Agreement and the First and Second Amendment, shall remain unaltered, shall continue in full force and effect, and are hereby ratified, approved and confirmed by the parties in every respect. If the terms and conditions set forth in this Third Amendment shall directly conflict with any provision contained in the Original Agreement and the First and Second Amendment, the terms contained in this Third Amendment shall control.
