FISCAL YEAR 2021-2022 FUNDING INCENTIVE PROGRAMS SUMMARY

At the September 28, 2021 CRA Board Meeting, the board approved a budget amendment that included an increase to the CRA's total funding assistance available. Economic development funding assistance remained at \$850,000 for fiscal year 2021-2022 and the Curb Appeal Residential Improvement Program was increased to \$300,000.

A-G.U.I.D.E.: Achieving Goals Using Impact Driven Evaluation

The A-G.U.I.D.E. FY 2022-2023 funding cycle was announced in May, with an application deadline of July 15, 2022. The Funding Evaluation Committee will meet to review and score each complete application and preliminary recommendations will be presented to the CRA Board at the September 1, 2022 CRA Workshop. Among the six (6) applicants, a total of \$1,103,000 is being requested. The following is a summary of the funding requests:




