

RESOLUTION NO. 133-22

A RESOLUTION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING THE ISSUANCE OF A PURCHASE ORDER TO STINGRAY CHEVROLET AND DUVAL FORD UTILIZING FLORIDA SHERIFF'S ASSOCIATION CONTRACT NO. FSA20-VEL28.0, FOR THE PURCHASE OF A 2023 TAHOE SUV AND A 2022 F-150 PICK-UP TRUCK TO REPLACE INOPERABLE CITY VEHICLES AND AUTHORIZING THE CITY MANAGER TO TAKE ANY AND ALL ACTIONS NECESSARY TO EFFECTUATE THIS RESOLUTION; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the Florida Sheriff's Association (FSA) administers a Cooperative Purchasing Program wherein it performs the solicitation for a multitude of products and administers the resulting contracts, and

WHEREAS, the prices or bids of the awarded vendors are extended and guaranteed to the Florida Sheriff's Association along with any unit of local government, political subdivision, or agency of the State of Florida; and

WHEREAS, the Florida Sheriff's Association issued solicitation FSA20-VEL28.0 to obtain vendors for police rated pursuit vehicles, special service vehicles, administrative vehicles, hybrid vehicles, electric vehicles, pick-up trucks, vans, mobility transport vehicles, and police motorcycles; and

WHEREAS, Stingray Chevrolet and Duval Ford are two of the vendors that were awarded Contract FSA20-VEL28.0; and

WHEREAS, the City desires to issue purchase orders to Stingray Chevrolet and Duval Ford utilizing the Florida Sheriff's Association Contract No. FSA20-VEL28.0, in order to replace inoperable city vehicles; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the issuance of purchase orders to Stingray Chevrolet for a 2023 Tahoe and Duval Ford for a 2022 F-150 utilizing the Florida Sheriff's Association Contract No. FSA20-VEL28.0, which is attached to this Resolution as Exhibit "A".

Section 3. The City Commission authorizes the City Manager to take any action necessary to effectuate this Resolution.

Section 4. This Resolution shall become effective immediately upon adoption.
