REINSTATEMENT AND FIRST AMENDMENT TO THE AGREEMENT FOR PROFESSIONAL CONSULTING SERVICES BETWEEN THE DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY AND SYNALOVSKI ROMANIK SAYE, LLC.

THIS REINSTATEMENT AND FIRST AMENDMENT TO THE AGREEMENT FOR PROFESSIONAL CONSULTING SERVICES ("First Amendment") is made and entered into as of the ____ day of ____, 2022, by and between the DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY, a public body corporate and politic, duly created and operated pursuant to Section 163, Part III, Florida Statutes, (hereinafter referred to as the "CRA"), and SYNALOVSKI ROMANIK SAYE, LLC. (hereinafter referred to as "ARCHITECT").

WITNESSETH:

WHEREAS, the CRA and the ARCHITECT previously entered into an Agreement for Professional Consulting Services dated October 1, 2018 ("Original Agreement"); and

WHEREAS, the CRA and the ARCHITECT agree to enter into a First Amendment to the Original Agreement to reinstate the Original Agreement and to extend the Original Agreement for an additional one (1) year term commencing on September 30, 2022 and terminating on September 30, 2023.

NOW THEREFORE, in consideration of the promises, mutual covenants, provisions and undertakings hereinafter contained and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. That the recitals set forth above are true and correct and are incorporated herein by reference.

- 2. Effective as of September 30, 2022, the CRA and the ARCHITECT hereby agree to reinstate the Original Agreement.
- 3. The CRA and ARCHITECT agree to hereby extend the Original Agreement for an additional one (1) year term, commencing on September 30, 2022 and terminating on September 30, 2023.
- 4. The CRA's Executive Director may further approve and amend the Original Agreement by executing a written agreement signed by both parties.
- 5. That except as amended herein, the CRA and ARCHITECT ratify, approve and reaffirm the terms of the Original Agreement, and the Original Agreement shall remain in full force and effect, except as amended herein.
- 6. In the event of any conflict or ambiguity by and between the terms and provisions of the Original Agreement and this First Amendment, the terms and provisions of this First Amendment shall control to the extent of any such conflict or ambiguity.
