## **RESOLUTION NO. 126-22**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING THE INVENTORY LIST OF CITY OWNED PROPERTY APPROPRIATE FOR USE AS AFFORDABLE HOUSING PURSUANT TO SECTION 166.0451, FLORIDA STATUTES; AND PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, Section 166.0451, Florida Statutes, requires that every three (3) years municipalities in the State of Florida prepare an inventory list of all real property within its jurisdiction to which the City holds fee simple title that is appropriate for use as affordable housing; and

WHEREAS, The inventory list must include the address and legal description of the property and specify if the property is vacant or improved; and

WHEREAS, City Commission must review the inventory list at a public hearing and make revisions if necessary; and

WHEREAS, The inventory of City owned vacant property has been deemed appropriate for use as affordable housing; and

WHEREAS, City Council finds and declares that adoption of this resolution is in conformance with the requirements of Section 166.0451, Florida Statutes.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The adoption of this resolution is necessary, appropriate, and in the public interest of the citizens of Delray Beach.

Section 2. The 2022 Inventory List of City Owned Property Appropriate for Use as Affordable Housing is hereby adopted pursuant to and in conformance with Section 166.0451, Florida Statutes.

<u>Section 3.</u> This Resolution shall become effective immediately upon adoption.
