THIS AGREEMENT, made and entered this 19th of June 2015, by and between the STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, hereinafter called the DEPARTMENT, and ALL ABOARD FLORIDA – OPERATIONS LLC, a Delaware limited liability company hereinafter called the COMPANY or AAF.

WITNESSETH

WHEREAS, the DEPARTMENT and the MPOs are desirous of having the COMPANY design, construct, and install along its corridor certain infrastructure as well as the required Supplemental Safety Measures (SSMs) to qualify the crossings from Broward to Palm Beach Counties, as a quiet zone, hereinafter referred to as the "PROJECT"; and

WHEREAS, the PROJECT includes two Financial Project Management Numbers, FM#: 435174-1-57-01 (Broward), and FM#: 435343-1-57-01 (Palm Beach); and

WHEREAS, 173 public grade crossings exist on the COMPANY's corridor within Broward and Palm Beach Counties, and the DEPARTMENT and the MPOs have identified SSMs and other specific infrastructure to improve safety along the COMPANY's corridor; and

WHEREAS, certain of the public grade crossings in the corridor have existing interconnection between railroad warning devices and the roadway traffic signals, all of which will be maintained or reestablished as part of the PROJECT; and

WHEREAS, the MPOs prioritized this PROJECT at the request of the Local Municipalities and the MPOs have directed the DEPARTMENT to facilitate the MPOs' funding for the design and construction of said PROJECT; and

NOW, THEREFORE, in consideration of the mutual undertaking as herein set forth, the parties agree as follows:

- The COMPANY will design the SSMs identified by the MPOs as necessary to qualify the corridor throughout Broward and Palm Beach Counties as a quiet zone.
- The COMPANY will also design the crossing related infrastructure including but not limited to
 items such as roadway improvements, sidewalks, cantilevers, and shared structures (to
 accommodate vehicular traffic signals and train signals), identified in Exhibit A and as has been
 determined by affected individual local governmental entities.
- 3. All design and construction shall be in compliance with generally accepted industry standards

and applicable State and Federal regulations.

- 4. The COMPANY has submitted plans to the DEPARTMENT and the MPOs. The DEPARTMENT has conducted its review by the use of the Electronic Review Comments (ERC) system, and has provided comments back to the COMPANY with respect to compliance with applicable FDOT standards on state roads. The COMPANY will continue to address comments submitted by the DEPARTMENT and the MPOs.
- In conjunction with the construction of this PROJECT, the COMPANY will be required to coordinate and obtain all required (non-preempted by Federal law) permits, including permits from the DEPARTMENT and local roadway jurisdictions.
- The COMPANY shall provide a complete set of plans and/or operational design sheets numbered, and with specifications of work to be performed by the COMPANY pursuant to the terms hereof.
- 7. Upon approval of the 100% design plans by the DEPARTMENT and submission of an updated construction cost estimate, COMPANY shall provide an invoice and the DEPARTMENT will reimburse the COMPANY in the lump sum amount of eight hundred eighty three thousand nine hundred and six dollars (\$883,906) for the design of the PROJECT. Funding for the design of this PROJECT is allocated and available for reimbursement in the DEPARTMENT's current fiscal year Work Program (July 1st, 2014 to June 30th, 2015). The budget has been established as summarized in Exhibit B.
- 8. The COMPANY recognizes the importance of coordinating with the DEPARTMENT and other affected local governments for any construction undertakings within half a mile of a railroad crossing, to minimize traffic delays due to construction activities. The COMPANY shall not be permitted to close two consecutive railroad crossings on State Roads unless otherwise approved by the DEPARTMENT.
- 9. Adequate reference shall be made in the billing to the COMPANY's records, accounts and other relevant documents. All cost records and accounts shall be subject to audit by representatives of the DEPARTMENT. Upon receipt of invoice, prepared in accordance with the provisions of the above- indicated reimbursement Policy, the DEPARTMENT agrees to reimburse the COMPANY in the amount of such actual costs approved by the DEPARTMENT's auditor.
- 10. Payment shall be made only after receipt and approval of goods and services unless advance payments are authorized by the State Comptroller under Section 215.422, Florida Statues.
- 11. In accordance with Section 287.058, Florida Statutes, the following provisions are in this Agreement: If this Contract involves units of deliverables, then such units must be received and accepted in writing by the Contract Manager prior to payments. Bills for fees or other compensation for services or expenses shall be submitted in detail sufficient for a proper preaudit and post-audit thereof.
- 12. In accordance with Section 215.422, Florida Statutes, the following provisions are in this Agreement: AAF should be aware of the following time frames. Upon receipt, the DEPARTMENT has five (5) working days to inspect and approve the goods and services, unless the Agreement specifies otherwise. The DEPARTMENT has 20 days to deliver a request for payment (voucher) to the Department of Banking and Finance. The 20 days are measured from the latter of the date the invoice is received or the date the goods or services are received, inspected, and approved.

If a payment is not available within 40 days, a separate interest penalty at a rate as established pursuant to Section 215.422 (3)(b), Florida Statues, will be due and payable in addition to the invoice amount, to the AAF. Interest penalties of less than one (1) dollar will not be enforced unless the AAF requests payment. Invoices which have to be returned to AAF because of AAF preparation errors will result in a delay in the payment. The invoice payment requirements do not start until a properly completed invoice is provided to the **DEPARTMENT**.

A vendor Ombudsman has been established within the Department of Banking and Finance. The duties of this individual include acting as an advocate for contractors/vendors who may be experiencing problems in obtaining timely payment(s) from a state agency. The Vendor Ombudsman may be contacted at (850) 410-9724, or by calling the State Comptroller's Hotline, 1-800-848-3792.

- 13. Records of costs incurred under terms of this Agreement shall be maintained and made available upon request to the DEPARTMENT at all times during the period of this Agreement and for three years after final payment is made. Copies of these documents and records shall be furnished to the DEPARTMENT upon request. Records of costs incurred includes the AAF's general accounting records and the PROJECT records, together with supporting documents and records of AAF and all subcontractors performing work on the PROJECT, and all other records of AAF and subcontractors considered necessary by the DEPARTMENT for a proper audit of costs.
- 14. In the event this contract is for services in excess of TWENTY FIVE THOUSAND DOLLARS (\$25,000.00) and a term for a period of more than one year, the provisions of Section 339.135(6) (a), Florida Statutes, are hereby incorporated:

The **DEPARTMENT**, during any fiscal year, shall not expend money, incur any liability, or enter into any contract which, by its terms, involves the expenditure of money in excess of the amounts budgeted as available for expenditure during such fiscal year. Any contract, verbal or written, made in violation of this subsection is null and void, and no money may be paid on such contract. The **DEPARTMENT** shall require a statement from the Comptroller of the **DEPARTMENT** that such funds are available prior to entering in any such contract or other binding commitment of funds. Nothing herein contained shall prevent the making of contracts for periods exceeding one year, but any contract so made shall be executory only for the value of the services to be rendered or agreed to be paid for in succeeding fiscal years; and this paragraph shall be incorporated verbatim in all contracts of the **DEPARTMENT** which are for an amount in excess of TWENTY FIVE THOUSAND DOLLARS (\$25,000.00) and which have a term for a period of more than one year.

15. In accordance with Section 287.133 (2)(a), Florida Statutes, the following provisions are included in this agreement:

A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases for real property to a public entity, may not be awarder or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in s.287.017 for CATEGORY TWO for a period of 36 months from the date of being placed on

the convicted vendor list.

16. In accordance with Section 287.0582, Florida Statutes, the following provisions are included in this Agreement:

The **DEPARTMENT**'s obligation to pay under this section is contingent upon an annual appropriation by the Florida Legislature; provided, however, the **DEPARTMENT** represents that the funds for completion of the design of the **PROJECT** have already been budgeted and allocated.

- 17. The **DEPARTMENT** reserves the right to unilaterally cancel this Agreement for refusal by the AAF or Agency to allow public access to all documents, papers, letters, or other material subject to the provisions of Chapter 119, Florida Statutes, and made or received in conjunction with this Agreement.
- 18. AAF's and Florida East Coast Railway's ("FECR") rights and duties regarding the sounding of the locomotive horns at the subject crossings shall be set out in 49 CFR Part 222, and by other applicable law. Nothing contained in this Agreement shall be construed to alter such rights and duties.
- 19. **DEPARTMENT** and the **COMPANY** agree that they will cooperate as necessary in defense of any claim, demand, investigation or litigation arising out of or related to this Agreement, the **PROJECT**, or the SSM's.
- 20. To the extent that this Agreement encompasses SSM's which are covered within the terms of certain Crossing License Agreements between applicable counties, municipalities, or the DEPARTMENT and FECR ("Licenses"), the installation costs of the SSM's will not be charged to the applicable counties, municipalities or the DEPARTMENT to the extent such costs are paid to AAF pursuant to this Agreement; provided, however, the future cost of maintenance of the SSM's shall be apportioned as provided in the Licenses, recognizing that those counties and municipalities are not a party to this agreement.
- 21. The **DEPARTMENT** will amend the existing crossing agreements for the state roads to update the future maintenance costs of the **PROJECT** improvements and to add AAF as a party to the agreements. AAF will coordinate with all local jurisdictions to provide for the cost of the upgraded facilities.
- 22. Any notices required or permitted to be given under this Agreement shall be in writing and shall be deemed to have been given if delivered by hand, sent by recognized overnight courier (such as Federal Express) in a postage-prepaid envelope, and addressed as follows:
