## CITY OF DELRAY BEACH AMENDMENT NO. 2 TO BID 2014-42 AGREEMENT FOR ELECTRICAL SERVICES AND REPAIRS

THIS AMENDMENT NO. 2 to the Bio	d 2014-42 Electrical Services and Repairs Agreement
dated March 6, 2015 by and between City	of Delray Beach, a municipal corporation of the State
of Florida (City), and Imperial Electrical, In	c. a Florida Corporation (Contractor), is entered into

## WITNESSETH:

WHEREAS, on March 6, 2015, City entered into an agreement with Contractor for electrical services and repairs in response to Bid 2014-42 ("Agreement"). The Agreement provides that the City to renew the Agreement for two (2) consecutive terms of one (1) year; and

**WHEREAS**, the City Commission retroactively approved Amendment No. 1 to renew the Agreement for the first one-year term through March 5, 2017; and

**WHEREAS**, On October 31, 2016, the Contractor agreed to continue providing services to City for the second and final one-year term in accordance with the terms and conditions of the Agreement.

**WHEREAS**, the City determines that it is in the best interest of the City to renew this Agreement to March 5, 2018.

**NOW, THEREFORE**, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 2 renews the Agreement, under the same terms and conditions, for the period of March 6, 2017 through March 5, 2018 for an annual amount not to exceed \$24,000.00.
- 3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement, Amendment No. 1, and this Amendment No. 2 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
