I. PROJECT DESCRIPTION

WGI will perform a review of the existing Clubhouse drawings, survey the onsite structural conditions of the structure and verify door and windows, roofing system and building cladding for hurricane and impact resistance. All systems should be evaluated against the current building code. Additionally, WGI will review the existing electrical capacity of the facility and identify vulnerabilities. WGI will prepare a written report summarizing the findings and will provide recommendations for the use of the facility as a temporary E.O.C., conceptual level improvements and costs associated with those improvements at various levels of protection including the current building code and cat 5 hurricane force winds.
