CITY OF DELRAY BEACH AMENDMENT NO. 1 TO ARCHITECTURAL COMPLIANCE REVIEW AGREEMENT

THIS AMENDMENT NO. 1 to the Architectural Compliance Review Agreement dated April 22, 2014 ("Agreement"), by and between City of Delray Beach, a municipal corporation of the State of Florida ("City"), and Alexis Knight Architects, Inc. organized and existing under the laws of the State of Florida ("Contractor") is entered into this _____ day of _____, 20___.

WITNESSETH:

WHEREAS, on April 22, 2014, City entered into the Agreement with Contractor for services provided. The Agreement was for a term of one year with an option to renew for two (2) consecutive terms of one (1) year; and

WHEREAS, the first term of the Agreement expired on April 21, 2015. However, Contractor has continued to provide services in accordance with the terms and conditions of the Agreement; and

WHEREAS, through inadvertence, an amendment to renew the agreement through April 21, 2016 and again through April 21, 2017 was not approved and executed by the City Commission; and

WHEREAS, Contractor, agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City determines that it is in the best interest of the City to retroactively approve Amendment No. 1 to renew the Agreement until April 21, 2017.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 1 renews the Agreement, under the same terms and conditions, through April 21, 2017 for an annual not-to-exceed annual amount of \$30,000.
- 3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby ratified and confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
