Statement of the Problem: (Provide details about the traffic safety problem that you want to address.)

When manufactured seat belts and child restraints are properly installed and utilized, studies show that they can save lives and prevent injuries. Delray Beach in located in Palm Beach County, FL. As of 2015, the population of Delray Beach consist of 63,939 residents (U.S. Census Bureau Facts).

In 2016, there was 3,803 crashes recorded in the City of Delray Beach which consisted of 12 traffic fatalities. Of those 12 fatalities, 2 victims were not wearing their safety belts at the time of the incidents. In 2016, according to FDOT (Florida Department of Transportation) the user rate for seat belts in the State of Florida was 89.6%. In Palm Beach County the user rate was 91.5%.

According to the FDOT Highway Safety Matrix in 2016, Delray Beach ranked 10# out of 99 cities in the county for cities with a population of 15,000-74,999 in regards to Occupant Protection (usage of safety belts). Motor vehicle crashes are the leading cause of deaths in the U.S. In 2015, more than 35,000 people died from motor vehicle crashes compared to 32,000 in 2014 (Insurance Institute for Highway Safety).

In 2016, the Delray Beach Police Department wrote 677 safety belt violations and 38 child restraint citations. This detailed information shows that many residents and their children are unrestrained occupants.

Based on detailed information there is strong evidence that safety belt laws, child restraint laws and educational programs are very effective ways to increase seat belt and child restraint usage (Safe Kids USA). In 2016, Delray Beach Police Department placed greater focus on pedestrian crashes due to 4 fatalities with motor vehicles which had occurred in the city. Messages boards, social media and press releases were used to educate pedestrians about traffic dangers that exist on city roadways.

The Delray Beach Police Department's Traffic Unit will conduct result-driven high visibily enforcement on major roadways where the majority of pedesrian/vehicle crashes occur in the City of Delray Beach. Officers will also conduct continued traffic safety belt enforcement on documented roadways. The Traffic Unit will also provide continued education through the issuance of warnings and citations.

The Delray Beach Police Department currently utilizes a solar powered ALS message boards to educate drivers on the importance of utilizing their safety beats. These signs are being used for public information and education methods. Areas in which the signs are used include: School Zones and heavily traveled roads during peak driving times. The signs are also used during statewide traffic enforcement campaigns, such as: "Click it or Ticket", etc.

The Delray Beach Police Department regularly posts traffic campaigns and enforcement information on social media including: Delray Beach Police Department Facebook, Twitter and Instagram accounts. The departments PIO also provides the public with first hand knowledge about taffic enforcement that is being utilized in the city.

It is the Delray Beach Police Department Patrol and Traffic Units mission to continue its long standing relationship with its residents. The Traffic unit will participate in community events to raise awareness and enforce safety belt and child restraint laws.

The Traffic Unit will continue to utilize message boards, social media and press releases to inform the public of enforcement areas in the city. Community events which take place in the city also provide officers the benefits of providing citizens and tourist the safety benefits of wearing safety belts. The Delray Beach Police Department maintains a full time traffic unit which has established a strong relationship with the citizens of Delray Beach. It is the sole responsibility of the traffic unit to ensure that all traffic laws and city ordinances are followed by every commuter. The traffic unit will continue to make traffic safety their top priority.

- 1. The Delray Beach Traffic Unit seeks to achieve their goals and objectives by educating the community in regards to wearing safety belts and providing children with proper child restraints throughout the project.
- 2. To increase public awareness about safety belt and child restraint usage by utilizing message boards, billboards, fliers, social media and press releases.
- 3. Conduct High Visibility Enforcement with the hope of decreasing the number of citations for safety belt usage in future years.
- 4. While participating in community events, enforcement contacts will be made to promote occupant protection safety.

The Delray Beach Police Department Traffic Unit will evaluate the success of the Occupant Protection Program by utilizing an outcome evaluation approach outlined by FDOT. The Traffic Unit will target drivers who fail to wear safety belts and provide their children with properly fitted child seats.

The Traffic Unit will educate drivers based the cause and effect method which can lower the amount of injuries and fatalities and also change the mindset of drivers in the city. Traffic Officers have access to and will be able to regularly utilize the Delray Beach database system (RMS), an instrument to properly evaluate officer's success.

Enforcement will be recorded and measured by the number of citations that are issued for safety belt violations and child seat violations. The Traffic Unit will also record the number of occupant protection presentations completed and community events attended.
