## CITY OF DELRAY BEACH AMENDMENT NO. 3 TO PARKING FACILITY MANAGEMENT AGREEMENT

THIS AMENDMENT NO. 3 to the Parking Facility Management Agreement dated December 22, 2015, by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and Ameristar Parking Solutions, LLC, organized and existing under the laws of the State of Florida and authorized to do business in the State of Florida (Second Party), is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2017.

## WITNESSETH:

**WHEREAS**, on December 22, 2015, the City retroactively approved an agreement with Second Party to provide Parking Facility Management Services for a term of October 15, 2015 to September 30, 2016 ("Agreement"); and

**WHEREAS**, on September 30, 2016, the City Manager approved Amendment No. 1 to extend the Agreement with Second Party for ninety days in accordance with the City's Code of Ordinances Section 36.07; and

**WHEREAS**, on December 6, 2016 City Commission approved Amendment No. 2 to extend the Agreement with Second Party through February 28, 2017 per City Code of Ordinances Section 36.07: and

WHEREAS, the City desires to continue to extend the Agreement until May 29, 2017 in order to compete negotiations for a new agreement for comprehensive parking management services.

**NOW, THEREFORE**, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 3 renews the Agreement, under the same terms and conditions, for the period of March 1, 2017 through May 29, 2017 in accordance with the City's Code of Ordinances Section 36.07.
- 3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement, Amendment No. 1, Amendment No. 2, and this Amendment No. 3 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
