AMENDMENT NO. 1 TO SOLICITATION NO. 2015-76 AGREEMENT FOR STATE LEGISLATIVE LOBBYIST

CITY OF DELRAY BEACH AMENDMENT NO. 1 TO STATE LEGISLATIVE LOBBYIST AGREEMENT

THIS AMENDMENT NO. 1 to the State Legislative Lobbyist Agreement dated October 6, 2015, by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and Ballard Partners, Inc. (Second Party), is entered into this ____ day of _____, 2017.

WITNESSETH:

WHEREAS, on October 6, 2015, the City entered into an agreement with Second Party for State legislative lobbyist services in an annual not-to-exceed amount of \$45,000; and

WHEREAS, the Agreement inadvertently stated that all duties, obligations, and responsibilities of Second Party shall be completed within thirty days of full contract execution by the City rather than the correct term of three years with the option for three one-year renewal periods; and

WHEREAS, Second Party continued to provide State legislative lobbyist services in accordance with the Agreement terms and conditions; and

WHEREAS, the City determines that is in the best interest of the City to retroactively approve this Amendment No. 1 to establish an Agreement term of October 6, 2015 through October 5, 2018 with the option of three one-year renewal periods; and

WHEREAS, Second Party agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 1 establishes an Agreement term of October 6, 2015 through October 5, 2018 with the option of three one-year renewal periods, subject to mutual acceptance by City and Second Party, in an annual not-to-exceed amount of \$45,000.
- 3. Article 3 Term and Time of Performance, Section 3.1 is amended as follows:

This contract is in full force and effect upon full contract execution by the City of Delray Beach. The Agreement term shall be from October 6, 2015 through October 5, 2018 with three, one-year renewal options. The continuation of this Agreement beyond the end of any fiscal year shall be subject to both the appropriation and the availability of funds in accordance with Florida law.

4. Article 3 Term and Time of Performance, Section 3.2 is hereby deleted.
