PROJECT TITLE: Lifeguard Towers – Skid Mounted

This Service Authorization, when executed, shall be incorporated in and shall become an integral part of the "Agreement for General Consulting Architectural Services" Contract dated May 15, 2017, as amended.

**I. PROJECT DESCRIPTION**

Services include the preparation of bid, permit, and construction documents for the modification of a previously prepared design (attached as Exhibit A).

**II. SCOPE OF SERVICES**

The architect will review current code requirements and revise documents as needed to prepare and submit new construction documents for issuance for permit and construction. The design will generally be replicated except that the uppermost roof element will not be included and the stands will be on wood skids. It is intended that one set of construction documents will be prepared for use by the City and will be re-used at other locations as determined by the City.

The following qualifiers and exclusions are included:

- Any design modifications will be considered added services.
- Submittal for review and approval to any City Board is not included herein.
- Approval by any other agency other than the City of Delray Beach Building Department is excluded.
- Services include architectural and structural engineering only. No civil, MEP, landscape or irrigation services.
- Final placement location is to be determined by the City so no surveys are proposed or included.

**III. TIME OF PERFORMANCE**

Once the Architect receives a written notice to proceed from the City, and a final approved design is accepted, permit documents will be provided in no more than 45 days from approval. Bid, permit, and construction services will be provided as requested by the City.

**IV. COMPENSATION**

Preparation of bid, permit, and construction documents for one base structure will be provided for a lump-sum fee amount of **Twenty Four Thousand Five Hundred Dollars (\$24,500.00) and No Cents**, including limited printing charges.

If additional services or fees are required not specifically noted above these can be provided as additional services and fees.

This service authorization is approved contingent upon the City's acceptance of and satisfaction with the completion of the services rendered in the previous phase or as encompassed by the previous service authorization. If the City in its sole discretion is unsatisfied with the services provided in the previous phase or service authorization, the City may terminate the contract without incurring any further liability. The CONSULTANT may commence work on any service authorization approved by the City to be included as part of the contract without a further notice to proceed.




