AMENDMENT NO. 4 TO
AGREEMENT FOR LAND SURVEYING CONSULTING SERVICES

THIS AMENDMENT NO. 5 to the Land Surveying Consulting Services Agreement dated April 5, 2012, by and between City of Delray Beach (City), a municipal corporation of the State of Florida, and Caulfield & Wheeler, Inc. (Consultant), organized and existing under the laws of the State of Florida, is entered into this ____ day of _____, 2017.

WITNESSETH:

WHEREAS, on April 5, 2012, City entered into an agreement with Consultant for land surveying consulting services in response to Solicitation No. 2012-07 (Agreement); and

WHEREAS, on May 6, 2014, Amendment No. 1 was executed to renew the term of the Agreement. Amendment No. 1 inadvertently stated that the renewal period was through April 5, 2015 rather than the correct date of April 4, 2015; and

WHEREAS, on May 1, 2015, Amendment No. 2 was executed to renew the term of the Agreement. Amendment No. 2 inadvertently stated that the renewal period was through April 5, 2016 rather than the correct date of April 4, 2016; and

WHEREAS, on May 13, 2016, Amendment No. 3 was executed to renew the term of the Agreement. Amendment No. 3 inadvertently stated that the renewal period was through April 5, 2017 rather than the correct date of April 4, 2017; and

WHEREAS, on April 14, 2017, Amendment No. 4 was executed to extend the term of the Agreement through July 3, 2017; and

WHEREAS, the City desires to extend this Agreement through September 30, 2017 to allow time to complete the evaluation of solicitation responses for a new agreement(s); and

WHEREAS, Consultant agrees to continue to provide Land Surveying Consulting Services to City in accordance with the terms and conditions of the Land Surveying Consulting Services Agreement.

WHEREAS, the City determines that it is in the best interest of the City to approve this Amendment No. 5 to extend this Agreement to September 30, 2017.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Land Surveying Consulting Services Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 5 extends the Agreement, under the same terms and conditions, for the period of July 4, 2017 through September 30, 2017.
3. The City may terminate this Agreement at any time, upon twenty-four (24) hours written notice.

4. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement, Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4 and this Amendment No. 5 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
