THIS AMENDMENT NO. 3 to the Electrical Services and Repairs Agreement dated January 21, 2015, by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and Universal Electric of Florida, Inc. (Contractor), a Florida Corporation, is entered into this \_\_\_\_ day of \_\_\_\_, 2017.

**WITNESSETH:**

**WHEREAS**, on January 21, 2015, City entered into an agreement with Contractor for electrical services and repairs in response to Bid 2014-42 ("Agreement"); and

**WHEREAS**, Amendment No. 1 renewed the Agreement for the first one-year renewal term through January 20, 2017; and

**WHEREAS**, Amendment No. 2 renewed the Agreement for the second one-year renewal term through January 20, 2018; and

**WHEREAS**, City determines that the annual spending amount with Contractor will exceed the not-to-exceed amount of \$25,000 as stated in Amendment No. 2, and

**WHEREAS**, Contractor agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

**NOW, THEREFORE**, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. Paragraph 2 of the Amendment No. 2 to the Agreement dated January 21, 2015 shall be amended to read as follows:

This Amendment No. 2 renews the Agreement, under the same terms and conditions, for the period of January 21, 2017 through January 20, 2018 for an annual amount not to exceed ~~\$25,000.00~~ \$60,000.00.

3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement, Amendment No. 1, Amendment No. 2, and this Amendment No. 3 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.


