### CITY OF DELRAY BEACH AMENDMENT NO. 1 TO BID 2014-42 ELECTRICAL SERVICES AND REPAIRS

THIS AMENDMENT NO. 1 to the BID 2014-42 Electrical Services and Repairs Agreement dated January 21, 2015 by and between City of Delray Beach, a Florida municipal corporation (City), and Universal Electric of Florida, Inc., a Florida corporation (Contractor), is entered into this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2017.

#### WITNESSETH:

WHEREAS, on January 21, 2015, City entered into the Agreement with Contractor for electrical services and repairs in response to Bid 2014-42 ("Agreement"). The Agreement provides that the City may renew the Agreement for two (2) consecutive terms of one (1) year; and

**WHEREAS**, on December 1, 2015 Contractor agreed to renew the Agreement for the firstone-year term in accordance with the terms and conditions of the Agreement; and

**WHEREAS**, this Amendment No. 1 to renew the Agreement through January 20, 2017 was not approved and executed by the City Commission; and

**WHEREAS**, on November 3, 2016, City notified Contractor of an administrative error in the preamble of the Agreement, which inadvertently stated that the execution date of the Agreement was "January 21, 2014" rather than "January 21, 2015".

WHEREAS, the City determines that it is in the best interest of the City to retroactively approve this Amendment No 1 to renew this Agreement to January 20, 2017 and to amend the date thereof.

**NOW, THEREFORE**, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 1 corrects the Agreement date and revises preamble of the Agreement to read as follows:

THIS AGREEMENT made this 21<sup>st</sup> day of January, <del>2014</del> <u>2015</u>, by and between the CITY OF DELRAY BEACH, (hereinafter called CITY) and Universal Electric (hereinafter called CONTRACTOR).

- 3. This Amendment No. 1 renews the Agreement, under the same terms and conditions, for the period of January 21, 2016 through January 20, 2017 for an annual amount not to exceed \$20,000.00.
- 4. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1

represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.

The Agreement, Amendment No. 1, and this Amendment No. 2 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
