AGREEMENT

THIS AGREEMENT is hereby made and entered into this _____ day of August, 2017, (the "effective date") by and between the City of Delray Beach, a Florida municipal corporation ("City"), whose address is 100 N.W. 1st Avenue, Delray Beach, Florida 33444, and MBR Construction, Inc., a Florida corporation (hereafter referred to as "Contractor"), whose address is 1020 NW 51st Street, Fort Lauderdale, FL 33309.

WHEREAS, the City desires to retain the services of the Contractor to provide the goods and services in accordance with the City's Invitation to Bid Construction No. 2017-060, and the Contractor's response thereto, all of which are incorporated herein by reference.

NOW, THEREFORE, in consideration of the mutual covenants and promises hereafter set forth, the Contractor and the City agree as follows:

ARTICLE 1. INCORPORATION OF INVITATION TO BID CONSTRUCTION

The terms and conditions of this Agreement shall include and incorporate the terms, conditions, and specifications set forth in the City's Invitation to Bid Construction No. 2017-060 and any addendum thereto (Exhibit A), and the Contractor's response to the Invitation to Bid Construction, including all documentation required thereunder (Exhibit B), all of which shall be attached hereto and incorporated herein.

ARTICLE 2. DESCRIPTION OF GOODS OR SCOPE OF SERVICES

The Contractor shall provide the goods and/or perform those services set forth in Exhibit A.

ARTICLE 3. COMPENSATION

The City shall pay to the Contractor, in compliance with the Pricing Schedule that was included in the Contractor's Bid, according to the terms and specifications of the referenced in Exhibit B.

ARTICLE 4. MISCELLANEOUS PROVISIONS

a. <u>Notice Format</u>. All notices or other written communications required, contemplated, or permitted under this Agreement shall be in writing and shall be hand delivered, telecommunicated, or mailed by registered or certified mail (postage prepaid), return receipt requested, to the following addresses:

This term of this Agreement shall be from the effective date through final completion and acceptance of the work by the City. Contractor shall have forty-five (45) days from the issuance of the Notice to Proceed to final completion unless terminated earlier in accordance with terms set forth in Exhibit A.
