Ms. Vargas had a series of setbacks in 2016 that left her struggling to care for her family. She was living in a pay by the week motel and had no transportation. Det. Rackauskas kept in touch with the family and delivered groceries to them on his off time. He also provided holiday gifts during Christmas. During the month of June, he reached out to Founder of Wheels From the Heart, Steven Muschlitz. This organization believes reliable vehicles can assist single mothers in need to achieve long-term sustainability for themselves and their children. On June 09, 2017, Ms. Vargas and her three children received a donated vehicle. Additionally, Det. Rackauskas made arrangements for the vehicle insurance to be paid by the Fraternal Order of Eagles – Delray Beach4476 group. This act of kindness is not uncommon for Det. Rackauskas. He is compassionate and gives from his heart. No doubt this act of kindness made a life altering change for Ms. Vargas and her children. Channel 25 and the Palm Beach Post aired this story. Currently, law enforcement nationally is struggling to overcome negative narratives. Not only did Det. Rackauskas shed a positive light on who he is, he shed a positive light on our agency, our city and the law enforcement profession. (See attached photographs)
