WHEREAS, the parties have agreed to extend the term of this Agreement for one (1) year, starting October 1, 2017 and ending September 30, 2018.

- 1. The recitations set forth above are incorporated herein.
- 2. That Paragraph 10, "**Term and Renewal**" shall hereby be amended as follows:
 - 10. <u>Term and Renewal</u>. The term of this Agreement shall be for three (3) years end September 30, 2018. If the **LICENSEE** has an account in arrears and/or is unable to provide proof of valid parking lot lease(s) and/or insurance, the license may be suspended until required payment and/or documentation is received.
- 3. This Amendment together with the original Agreement and any written amendments hereto, constitute the entire Agreement between the parties relating to the subject matter hereof. It is the final expression of agreement between the parties, thus, neither party shall be entitled to rely upon any conflicting oral representations, assurances, claims or disclaimers, made either prior to or simultaneous with the execution of this Amendment.

4. Except as expressly modified in writing herein or as modified by subsequent written amendments, all other terms and conditions of the original Agreement and any amendments thereto survive this Amendment and are deemed to be incorporated herein and are binding on the parties.
