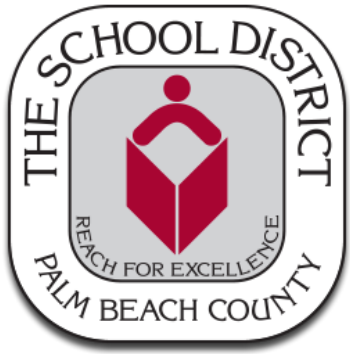
ISSUE STATEMENT

There is an increasing number of community members who are experiencing homelessness or are at risk of homelessness in Delray Beach. The Delray Beach Homeless Taskforce was created to respond to this community challenge.

Delray Beach Homeless Taskforce

Timeline

- **2015** – Sgt. Darrell Hunter and DB Police Department form a local group to address homelessness in the City
- **Jan. 2016** – Asst. City Manager initiates the DB Homeless Initiative
- **Jan.-Aug. 2016** – Initiative merges with DBPD group; meeting regularly with providers to collaborate and collect data
- **August 2016** – DB Homeless Initiative presents recommendations to City Commission; DB Homeless Taskforce is formalized with City Commission support
- **September 2016-Present** – monthly Taskforce meetings; 3 sub-committees (Programming, Policy, and Education and Outreach) working on specific activities
- **October 2017** – City Commission requests Taskforce update presentation
- **February 2018** – Original sunset date

DELRAY BEACH HOMELESS TASKFORCE

Success

September 2017

15 partners join the Taskforce that exists today

July 2017

Homeless Mini-Connect offered 17 providers/services to 90 individuals and families at St. Matthews Church

October 2017

Operation Homeless Connect at Pompey Park – to include 35 providers and assistance services at NO CHARGE

January 2017

More than 10 DB volunteers were trained and participated in Pam Beach County Point-In-Time (census study)
90 Delray Beach individuals identified in count

August 2017

Student Weekend Foodpacks Subcommittee collaborating with local providers to feed and fund 100% of homeless students in Delray Beach
(177 total)

SHORT TERM SOLUTIONS

COMMUNITY AWARENESS CAMPAIGN

- Provide educational collateral
- Teach community about the rights and responsibilities of homeless individuals
- Offer Homeless Initiative workshops

- ✓ A homeless advisory group to the city

✓ INVOLVE LOCAL FAITH-BASED ORGANIZATIONS/ PLACES OF WORSHIP

CLEAR DIRECTION FROM THE COMMISSION REGARDING ENFORCEMENT POLICIES

INCREASE IN FUNDING FOR RENTAL ASSISTANCE

✓ VOLUNTEERS FOR THE POINT-IN-TIME DATA COLLECTION

✓ MEMORANDUM OF UNDERSTANDING WITH THE LEWIS CENTER AND DELRAY BEACH POLICE DEPARTMENT

✓ OUTSIDE RESOURCES ENGAGED TO PROVIDE SERVICES TO DELRAY BEACH

LONG TERM SOLUTIONS

ORDINANCE/POLICY

- Goal to lessen the adverse effects of homelessness
- Would not be punitive

STORAGE OPPORTUNITIES

- A place for homeless individuals to store belongings – 96 Gallon containers, lockers, etc.
- Support Caring Kitchen as a possible location

CHALLENGES

- **Service interruption with relocation of the Caring Kitchen**
- **Logistical challenges to providing services such as affecting Live Fresh Truck and other services**
- **Limited available resources for people whom are homeless**
- **Insufficient housing and support for individuals and families at risk of homelessness**
- **Public awareness and education around homelessness**
- **More time needed to accomplish solutions**
