THIS AMENDMENT NO. 1 to Pompey Park Three (3) Baseball Fields Maintenance dated April 5, 2016 by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as City), and STO Landscape Services, Inc. (hereinafter referred to as "Contractor"), a Florida corporation, whose address is 9870 Sun Pointe Drive, Boynton Beach, FL 33437, is entered into this 20 day of ~~SEPTEMBER~~ 2017.

WITNESSETH:

WHEREAS, the City issued ITB No. 2016-071 to provide Pompey Park Three (3) Baseball Fields Maintenance services on February 2, 2016, and Supplier submitted a response to the solicitation;

WHEREAS, the original agreement pursuant to ITB No. 2016-071 provided for a one year agreement with two one year renewals, for a total of three (3) years; and

WHEREAS, on April 5, 2016, the City Commission awarded a one-year agreement to Contractor for Pompey Park Three (3) Baseball Fields Maintenance services; and

WHEREAS, as an oversight, no amendment was formalized when the parties intended to exercise the first option to renew the agreement through 2018; and

WHEREAS, the City determines that it is in the best interest of the City to retroactively approve this Amendment No. 1 to extend the Agreement through April 4, 2018.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 1 retroactively extends the Agreement, under the same terms and conditions, for the period of April 5, 2017 through April 4, 2018 for a one year term not-to-exceed amount of Thirty Eight Thousand One Hundred and Sixty Dollars (\$38,160.00).
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
