



5. Restoration Manager and crew of Techs dispatched to job location.
6. Restoration Manager assesses and determines protocol for remediating situation.
7. Restoration Manager/Crew Leader obtains signed customer authorization form including insurance information.
8. Restoration Manager documents loss with photos, notes & directs crew before and during the remediation process.
9. Upon completing initial dry-out or remediation, advise customer of next step - proposal for rebuild and/or additional remediation.
10. Submit detailed proposal and obtain signed contract.
11. Restoration Manager needs to visit job site and meet with customer daily throughout the process.
12. Receive signed certificate of satisfaction.
13. VP Operations to contact customer to insure we have met clients needs and fulfilled our obligations to obtain closure.
14. Create bill and send invoice to responsible payee.

15.13 Approach / Methodology

Below is a list of key steps and SOP of Dean Mitchell's standards to responding to **infectious disease** incidents:

Infectious disease response protocol needs to be handled on a case by case basis depending on the environment and situation being remediated. Listed below is a general overview of how our staff will respond to a request made by the School District of Palm Beach County.

1. Upon initial call our Restoration Manager will contact Kesta James, Environmental Manager, at the School District of Palm Beach County to determine scope of work.
2. Based upon the scope of work, appropriate staff, supplies and equipment will be dispatched to said job.
3. Upon arrival to the site our immediate protocol is to insure safety of all occupants prior to utilizing appropriate chemicals.
4. Throughout the process key management will be onsite to insure SOP and proper PPE is being followed in accordance with the guidelines being provided by School District representative.
5. Upon completion of services make contact with appropriate School Representative.

15.14 Time of Completion

The Dean Mitchell Group staff is available anytime day or night, 365 days a year to respond and assist with District projects. Dean Mitchell Group has a 24/7 emergency call service which will dispatch a minimum of one of the (5) four-person crews which are on rotation call throughout the month. All key management personnel are on call 24/7 to meet District expectations. Additionally our five certified crew leaders are on call rotation so that we can have a fresh crew ready when our clients need us.

The Dean Mitchell Group provides double the industry standard bonus for all emergency staff that are on call. This keeps our staff highly motivated to respond to all emergency situations.

A key factor to limiting our response time is having an abundance of state-of-the-art emergency equipment.
