Plan adaptation comprehensively

What we are Doing

- Addressing Climate Change issues during current Comprehensive Plan update
 - Future Land Use Element
 - Coastal Element including postdisaster redevelopment policies
- Building Code already requires additional 12 inches of finished floor elevation above the base flood level
- City landscape code already permits and encourages Xeriscape

- Revise Building Codes to address:
 - Vulnerable and Adaptation Action Areas
 - Incorporate water retention infrastructure
 - Create fast track approaches to increase resiliency
 - Assess building height restrictions
 - Incentivize free board
 - Review and change if necessary location of building mechanicals
- We do not plan to request passage of an ordinance requiring landlords to provide air conditioning.

What we are Doing

- Community Rating System (CRS)
- Capital Improvement Program (CIP)
 - Ensure all capital improvement projects address potential impacts due to climate change
- Creating a Climate Adaptation Fund
 - Public Art Project

 - PACE Program
- Create a model resilience plan
 - Included in Climate Action Plan
- Investigate creation of a program offering Resilience Bonds

Educate the public

What we are Doing

- Identify and sponsor climate education programs
 - King Tide Education event
 - Earth Day event
 - Sea Turtle Nesting Season awareness
- Raise awareness at public events in Delray Beach
- Website and news articles
- City Staff is working with School Board on programs
- City Staff is attending relevant conference and workshops

- Improve the city's parcel database and make it accessible
- Support innovative data collection that engages citizens
- Work with the real estate community on proactive solutions regarding disclosure
- Post floor elevation place cards for all public buildings (similar to capacity numbers used in public meeting spaces)

Harness economic development

What we are Doing

- We send City Staff to participate and present on climate issues at professional functions
 - Subject matter expert presentations have been provided to:
 - Homeowner Associations
 - Schools
 - Florida Shore and Beach Preservation Association statewide conference on sea level rise and resiliency

- Use press and media to generate positive image of City's commitment to climate education
 - Public Information Officer coordinates and retrieves relevant climate-related information from appropriate departments to pitch to local/national press for coverage.
