


Bid 2015-032 - AGREEMENT FOR LIME SLUDGE REMOVAL AND DISPOSAL

THIS AMENDMENT NO. 1 to the Bid 2015-032 – Lime Sludge Removal and Disposal dated April 15, 2015 by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and Dev-land Demolition & Site, Inc. (Contractor), is entered into this May day of May, 2017.

WITNESSETH:

WHEREAS, on April 15, 2015, City entered into an agreement with Dev-land Demolition & Site, Inc. in response to Bid 2015-032 ("Agreement"). The term of the Agreement is two (2) years, with the option to renew for two (2) consecutive terms of one (1) year; and

WHEREAS, the parties desire to exercise the First option to renew the Agreement for one year; and

WHEREAS, the City determines that it is in the best interest of the City to approve this Amendment No 1 to renew this Agreement to April 14, 2018.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:


1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 1 renews the Agreement, under the same terms and conditions, for the period of April 15, 2017 through April 14, 2018.
3. Based on the Bureau of Labor Statistics Data, the City of Delray Beach can accept an increase from \$5.97 per cubic yard to \$6.07 per cubic yard for sludge removal and disposal up until April 14, 2018; all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.




