## **RESOLUTION NO. 39-18**

A RESOLUTION OF THE CITY COMMISSION OF DELRAY BEACH, FLORIDA, APPROVING THE APPLICATION TO THE TRANSPORTATION ALTERNATIVES PROGRAM THROUGH THE PALM BEACH TRANSPORTATION PLANNING AGENCY FOR THE CONSTRUCTION OF PROTECTED BIKES LANES AND SHARED USE PATHS ON CARL BOLTER DRIVE FROM BLUE JAY TURN TO LINDELL BLVD. AS PART OF AN EXTENSION OF THE BRANT BRIDGE CONNECTION LOOP; AUTHORIZING THE MAYOR OR CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

**WHEREAS**, the City Commission recognizes that multimodal methods of mobility and accessibility are important aspects of City planning efforts; and

**WHEREAS,** it is incumbent upon community leaders to ensure the health, safety, and welfare of residents and visitors in Delray Beach; and

**WHEREAS**, the City Commission desires to improve multimodal mobility options and accessibility for all residents and visitors throughout the City; and

**WHEREAS**, the City of Delray Beach desires to install bicycle and pedestrian pathways together with multi-use roadways as an integral part of these efforts and apply for funding related to construction of said projects.

## NOW THEREFORE, BE IT RESOLVED THAT:

- 1. The foregoing recitals are incorporated herein as true and correct findings of the City Commission.
- 2. The City Commission hereby approves the City's application for Transportation Alternatives Program funding through the Palm Beach County Transportation Planning Agency to add shared use paths, protected bike lanes (cycle tracks), pedestrian-scale lighting, and landscaping on Carl Bolter Drive between Blue Jay Turn and Lindell Blvd. in support of the City's Complete Streets Policy for multimodal mobility, accessibility, and aesthetics.
- 3. The City Commission hereby authorizes the Mayor or City Manager to conduct activities necessary to make the Transportation Alternatives Program funding successful through the Palm Beach County Transportation Planning Agency for establishing this part of Carl Bolter Drive as a Complete Street.
- 4. This Resolution shall take effect upon adoption.
