ITBC NO. 2017-038 IS HEREBY AMENDED AS SET FORTH HEREIN BELOW. CITY RESPONSES TO QUESTIONS POSED BY PROSPECTIVE BIDDERS ARE ALSO PROVIDED BELOW. THIS ADDENDUM NO. 2 IS HEREBY INCORPORATED IN AND MADE A PART OF ITBC NO. 2017-038.

QUESTIONS AND RESPONSES:

- Q1. Does demolition on Sheet S2.0 go to column line 7 and column line 2?
- R1. All pile remnants on grid line 2 through grid line 6 are to be removed. Timber deck, joists and beams between grid lines 6 and 7 are to be removed.
- Q2. Some of the existing piles in burn area are not visible. Do we need to excavate down to locate then remove?
- R2. Yes. We are installing new piles in the same locations.
- Q3. Sheet S3.1 Floor Framing Plan: Please provide area of new construction.
- R3. All framing between grid 1 and grid 7 is new.
- Q4. On Sheet S5.0, Details 1, 2, and 3 seem to show wood attached to the bottom of trusses. Please clarify.
- R4. Ceiling boards on underside of roof trusses should be 1x6 boards, So. Pine No. 1, S4S, Pressure Treated as per Lumber Notes on sheet S0.1.

- Q5. The piles listed on Sheet S3.0 will vary in length (27 feet, 38 feet, and 55 feet). I don't think the 10" piles will be available in 55' length. Please verify.
- R5. P3 Piles (the long piles) are called to be 12" butt piles.
- Q6. There is no detail shown for 4x4 railing posts that attach to floor joists. Only details 1, 2, and 3 on Sheet S5.1 shows at 3x12 girders. Please provide detail.
- R6. 4x4 posts should bolt to the joists with (2) ½" Dia SS 316 bolts as shown in the details. Where condition occurs between girders, add full-depth blocking between joists to fall on grid line 5.
- Q7. Detail 3 on Sheet S5.1 appears to be wrong. Please verify.
- R7. On plan Sheet S3.2, the section mark to Detail 3 on Sheet S5.1 should be located about an inch to the right to fall on grid line 5. With the exception of this revision, Detail 3 on Sheet S5.1 is correct.
- Q8. Please provide clarification of specification Section 1500 requirements. The items listed below will drive up the cost of the project and don't seem to be needed.
