QUESTIONS AND RESPONSES:

- Q1. Specification Section 01410 Testing and Laboratory Services states “The Owner will employ services of an Independent Testing Laboratory to perform specified testing.” Specification section 01025 Measurement and Payment 1.02D. states “Density testing required for compacted backfilling, and concrete strength and materials testing required at the time of construction shall be arranged for and paid for by the Contractor. Please confirm which direction the City desires with respect to reimbursement for concrete and density testing.
- R1. **The Contractor will employ services of an Independent Testing Laboratory to perform specified testing. Section 01410 has been revised per this Addendum No. 4.**
- Q2. Please forward Phase I itemized pricing, as discussed at the December 13th, 2017 pre-bid conference.
- R2. **Phase 1 Pricing Schedule has been added to ITBC No. 2018-018 as Exhibit E, per this Addendum No. 4.**

SECTION 01410 TESTING LABORATORY SERVICES

PART 1 - GENERAL

1.01 REQUIREMENTS INCLUDED

- A. The **Contractor** will employ services of an Independent Testing Laboratory to perform specified testing.
 - 1. Contractor shall cooperate with laboratory to facilitate the execution of its required services.

1.02 LIMITATIONS OF AUTHORITY OF TESTING LABORATORY

- A. Laboratory is not authorized to:
 - 1. Release, revoke, alter or enlarge on requirements of Contract Documents.
 - 2. Approve or accept any portion of the Work.
 - 3. Perform any duties of the Contractor.

1.03 CONTRACTOR'S RESPONSIBILITIES

- A. Cooperate with laboratory personnel and/or Engineer, provide access to Work or manufacturer's operations.
- B. Secure and deliver to the laboratory adequate quantities of representational samples of materials proposed to be used and which require testing.
- C. Provide to the laboratory the preliminary design mix proposed to be used for concrete, and other material mixes which require control by the testing laboratory.
- D. Furnish copies of Products test reports as required.
- E. Furnish incidental labor and facilities:
 - 1. To provide access to Work to be tested.
 - 2. To obtain and handle samples at the Project site or at the source of the product to be tested.
 - 3. To facilitate inspections and tests.
 - 4. For storage and curing of test samples.
- F. Notify the CEI sufficiently in advance of operations to allow for laboratory assignment of personnel and scheduling of tests:

When tests or inspections cannot be performed after such notice, reimburse Owner for laboratory personnel and travel expenses incurred due to Contractor's negligence.

- G. Make arrangements with the Engineer and the laboratory and pay for additional samples and tests required for Contractor's convenience.

PART 2 - PRODUCTS

PART 3 - EXECUTION

3.01 PAYMENT

- A. Testing of materials and products will be performed by an independent testing laboratory appointed and paid for by the Contractor. Testing will be performed so as to least encumber the performance of Work.
- B. The Contractor will be authorized the cost of one (1) series of tests only, on the area or item being evaluated. The Contractor shall pay for costs of additional testing as required due to improper performance of Work.
- C. When work of this contract or portions of work are completed, notify the Engineer so that arrangements can be made with the laboratory to perform or witness the tests. Do not proceed with additional portions of Work until results have been verified.
