That the Grantor agrees to provide for the release or subordination of any and all mortgages or liens encumbering this easement. The Grantor is permitted and authorized to make the improvements as specifically shown on Exhibit "B" but agrees to erect no building or affect any other kind of construction or improvements upon the above-described property without prior consent of the Grantee. The Grantee shall have the right to remove any permanent or temporary structure in order to access the easement for maintenance or repair of the public utilities/drainage facilities. Grantee shall not be responsible for repairing any structures damaged or destroyed while accessing the easement for maintenance or repair; the Grantee shall only be responsible for restoring the affected area with sod.
