Mayor Glickstein noted that there was one item on today's agenda, a discussion of the proposed 2017-2018 CRA budget. Jeff Costello, Executive Director of the Delray Beach CRA, provided an in-depth summary of the status of this year's CRA budget to date as well as next year's proposed budget. Mr. Costello also provided detailed updates of ongoing capital projects. Interim City Manager Neal deJesus noted that there had been very good collaboration between City staff and CRA staff in development of the proposed CRA budget. Mr. Costello and Mr. deJesus responded to questions from the Mayor and City Commissioners and members of the CRA Board. There was consensus by both entities to accept the proposed budget.
