CRA Q3 A Guide Report- April 1, 2018 to June 30, 2018

Program A

This 3rd quarter, the Delray Beach Public Library welcomed 27,472 patrons into the library and issued 344 new adult library cards (78% and 84% of full year target outputs respectively). The library issued 62 new Juvenile cards. Adult programing recorded 65 adult programs presented with attendance numbers (692) reaching 59% of output target. This attendance created a patron savings of \$6,207.00 (using an average ticket price of \$8.97 as established by the National Association of Theater Owners). The Delray Library checked out 8,334 print items, 2,119 audio-visual, and 1,050 EBooks (68%, 65% and \$176% of totals respectively). This represents a patron savings (using \$20.00 per item as an average) of \$230,060 – 59% of output target. The Delray Beach Public Library realized a personnel expense savings of \$8,401 resulting from 348 volunteer hours (calculated by an average hourly wage for non-profit employees of \$24.14 as established by independentsector.org). The Library's Reference Services assisted patrons 4,214 times this quarter (96% of total output target).

Program B

In Q3 the number of one-on-one consultations remained consistent with 37 distinct customers being served at the Library's Business Resource Center. This quarter our services have included providing assistance with business planning, review of financials, preparing for application to the CRA grant programs, marketing strategy, capital access guidance and strategic planning and guidance.

Six workshops from the Building a Smarter Small Business Seminar Series were held at the library with a total of 51 participants. Topics covered included: Cash Flow Management, Key Elements of Business Planning, Being a Leader, and Start Smart (for those with a business concept) and Launching a Business (those in the early stages of startup). A remaining course will be offered on July 10th: How to be Certified as a Disadvantaged, Minority or Woman-owned Business.

We are in the process of finalizing the design for the brochures that will have general SBDC information for our Spanish and Creole business leaders as to how they can receive one-on-one consulting services.

The three Construction Seminars have evolved into a Construction Conference titled "Go Build Delray" to be held on September 15th at the Delray Beach Library. The half day conference will begin with a panel of contractor representatives discussing their view of the needs of the industry in relation to the planned development projects coming to Delray Beach. The rest of the morning then provides breakout sessions on a variety of topics both technical and business management related. Currently we are holding focus groups with potential members of the panel and target audience to tighten up the design. The intent of the conference is to facilitate a base-line assessment of the needs of our sub-contractor population in order to develop a long-term support system. This support system should include not only addressing the technical needs of having a construction trade business (such as certification, licensing, permitting) but also the skills and knowledge needed to manage and grow such a business.
